Happy new fiscal year, which began on *July 1, 2024*. I know many of you, including myself, are excited about the upcoming Fourth of July holiday and spending time with family and friends. It seems like yesterday we were at commencement and attending the many year-end student celebrations. Now, we are in the second sixweek summer session and are already planning for the upcoming fall 2024 semester. Time flies when you are having fun.

Summer and Fall 2024 Enrollment Update

As of *Monday*, *July 1*, *2024*, Compton College has generated:

- 546 FTES for the **Summer 2024** term. The fill rate is currently 76%, and the seats filled is 4,513.
- 850 FTES for the **Fall 2024** semester. The fill rate is currently 32%, and the seats filled are 5,450.

Please continue to encourage students, community members, friends, and anyone interested in higher education to consider enrolling at Compton College in the fall. We are implementing various recruitment strategies for the fall 2024 semester.

Compton College COVID-19 Protocol

The *July 16, 2024*, Compton Community College District Board of Trustees meeting will be held in Room 212 in the Student Services Building. The closed session begins at 5:00 p.m., with the open session commencing at 6:00 p.m.

President/CEO Closing the Loop

We will postpone the implementation of the Registration Holds and Drops for Non-Payment until the 2025-2026 academic year. Admissions & Records, the Bursar's Office, and Community Relations are working on a timeline where these new processes will go into effect before fall registration begins in late April/early May 2025. Administrative Regulation 5030 - Fees was recently updated for consistency and accuracy in terms of refunds and optional fees and was Board-approved on *May 21, 2024*. Administrative Regulation 5030 - Fees requires students to pay fees within ten days of their enrollment in classes. In the meantime, we will continue to encourage students to pay their fees promptly and make sure it is clear which fees are optional.
