#### Campus Community,

As we approach the end of another productive week, let's look forward to the fall semester, which is just a month away. Next week will be our last 4/10 workweek, with *Friday, August 2, 2024*, as our final summer Friday off. Let's enjoy this well-deserved break as we prepare for the exciting opportunities that await us this fall. This week, we had over 100 high school students from Compton and Lynwood unified school districts participating in the 2024 Compton College High School Band Camp. In the President/CEO Message – July 11, 2024, I provided an update on the 2024-2025 California State Budget and the development of the 2024-2025 Compton Community College District Final Budget Assumptions. Although our initial 2024-2025 Compton CCD Final Budget Assumptions were shared with the Planning and Budget Committee this week, we will continue to make modifications. Please note, as always, we are focused on ensuring the 2024-2025 Compton CCD Final Budget is aligned with Board Policy 1200 - Mission, Vision, and Strategic Initiatives, and taking into account future year budgets. As we make commitments for 2024-2025 Budget Augmentations and Enhancements for 2024-2025, we must make sure appropriate funding is available in the 2024-2025 year and in the future to continue to support Guided Pathways, Strong Workforce, Enterprise Resource Planning System, and Scheduled Maintenance Facilities Projects. The 2024-2025 Compton CCD Final Budget will be presented to the Compton CCD Board of Trustees at their *Tuesday, September 10, 2024*, Board meeting.

### Fall 2024 Enrollment Update

As of *today, July 25, 2024*, Compton College has generated 1,210 FTES for the fall 2024 semester. The fill rate is currently 48%, and the seats filled are 8,232.

The <u>Fall 2024 registration reminder postcard</u> will be mailed to all in-district residences in 2 weeks. The postcard includes information about this year's <u>News Student Welcome Day</u>, scheduled for *Wednesday*, *August 21*, 2024. When you have a moment, please review the Fall 2024 registration reminder postcard; I am excited about the information we are sharing.

### Fall 2024 Peak Registration Services and Hours

The Student Services Division will be open for extended hours from *August 19 – September 6, 2024*, to help students complete their admissions applications, apply for financial aid, and register for fall classes.

Admissions & Records, Welcome Center, Counseling, Transfer & Career Center, CalWORKs, Special Resource Center, EOPS/CARE NextUp, Financial Aid, Student Development Office, Veterans Resource Center, and the Bursar's Office will be open Monday through Friday from 8:00 a.m. to 6:30 p.m., Fridays from 8:00 a.m. to 4:30 p.m., and two *Saturdays – August 17 and 24*—from 8:00 a.m. to Noon.

### Fall 2024 Professional Development Day

Once again, we are excited to announce that we will begin the fall 2024 semester with our mandatory Professional Development Day on *Thursday, August 22, 2024*. The general session will commence at 9:00 a.m. and conclude at 4:00 p.m. All full-time Compton College faculty and classified professionals are required to participate in the mandatory Professional Development activities on *Thursday, August 22, 2024*. We are honored to welcome Dr. Lori Patton Davis, Professor from the University of California, Los Angeles, as our keynote speaker. Dr. Patton Davis is a highly esteemed scholar in higher education, renowned for her work on

African Americans in higher education, critical race theory, and campus diversity initiatives. She has authored over 50 peer-reviewed articles and has been featured in top journals such as The Journal of Higher Education and Teachers College Record. Her research has been cited nearly 5,000 times. As the immediate past president of the Association for the Study of Higher Education and former Equity and Inclusion Officer for AERA Division J, she has significantly influenced educational policy and practice. Dr. Patton Davis holds a Ph.D. from Indiana University and has received numerous awards for her scholarly contributions, making her a sought-after education expert.
