**RESOLUTION MAKING A PROVISIONAL APPOINTMENT TO FILL A VACANCY  
ON THE BOARD**

**RESOLUTION NO. 03-09-2026A**

**RESOLVED**, by the Board of Trustees of the Compton Community College District, County of Los Angeles, State of California, that:

**WHEREAS**, on January 12, 2026, Trustee Barbara Calhoun submitted her resignation with a deferred effective date of February 1, 2026. On January 13, 2026, the President/Chief Executive Officer forwarded Trustee Calhoun's resignation to the Los Angeles County Superintendent of Schools; and

**WHEREAS**, Trustee Calhoun's resignation creates a vacancy in Trustee Area 2, representing the communities of Willowbrook, Enterprise, Compton, and West Rancho Dominguez; and

**WHEREAS**, the most recent election for Trustee Area 2 was in November 2024, and the next regularly-scheduled election for Trustee Area 2 will occur in November 2026, at which time an election will be held to fill the position representing Trustee Area 2, for the remainder of the four-year term through December 2028; and

**WHEREAS**, California Education Code section 5091(a) requires the Board of Trustees, within 60 days of the filing of the resignation, either to order an election or to make a provisional appointment to fill the vacancy created by the resignation of a Board member, and further provides that in the event the Board fails to order an election or to make a provisional appointment within the prescribed 60-day period, the county superintendent of schools shall order an election to fill the vacancy; and

**WHEREAS**, California Education Code section 5091(e) provides that person appointed to fill a vacancy shall hold office only until the next regularly scheduled election for district governing board members that is scheduled 130 or more days after the effective date of the vacancy, whereupon an election shall be held to fill the vacancy for the remainder of the unexpired term. A person elected at an election to fill the vacancy shall hold office for the remainder of the term in which the vacancy occurs or will occur; and

**WHEREAS**, insofar as the next regularly scheduled election for district governing board members that is scheduled 130 or more days after the effective date of the vacancy (i.e. February 1, 2026) will occur on November 3, 2026, an appointee will hold office until the date of the next regularly scheduled election on November 3, 2026, unless a timely petition by registered voters for a special election, with sufficient signatures, is approved by the Los Angeles County Superintendent of Schools; and

**WHEREAS**, a provisional appointment, unless successfully challenged by a petition calling for a special election pursuant to Education Code section 5091(c), confers all powers and

duties of a Board member upon the appointee immediately upon the appointment becoming effective; and

**WHEREAS**, it is this Board’s intent to make a provisional appointment to fill the vacancy in Trustee Area 2 existing by reason of Trustee Calhoun’s resignation; and

**WHEREAS**, pursuant to Education Code section 72103(a), any person, regardless of sex, who is 18 years of age or older, a citizen of the state, a resident of the community college district, a registered voter, and who is not disqualified by the Constitution or laws of the state from holding a civil office, is eligible to be elected or appointed a member of a governing board of a community college district without further qualifications; and

**WHEREAS**, pursuant to and as authorized by Education Code section 72022, Board Policy 2100 provides for the election of Trustees by trustee geographical areas; and

**WHEREAS**, [Board Policy 2010 - Board Elections](#) provides that any person who meets the criteria contained in law is eligible to be elected or appointed a member of the Board;

**NOW THEREFORE BE IT RESOLVED AND ORDERED AS FOLLOWS:**

1. That pursuant to and as authorized by Education Code section 5091, the Board of Trustees hereby appoints Dr. Nicole J. Jones as a member to fill the vacancy in Trustee Area 2. The appointment shall become effective upon the appointee taking and subscribing the required oath or affirmation. The appointee shall hold office until the qualification of a successor following the next regularly scheduled election for Board members to be held in November 2026, unless the appointment is terminated earlier as provided in Education Code section 5091(c)(2).
2. That within 10 days of the date of this Resolution, the President/Chief Executive Officer shall cause to be posted a public notice of vacancy and provisional appointment, in the form and manner required by Education Code section 5092;
3. That the Board delegates to the President/Chief Executive Officer all authority necessary and proper to the accomplishment of the purposes of this Resolution.
