As the Spring semester winds down, I write to remind everyone to complete their program reviews (if applicable). I know we are all physically and mentally drained, as we have gone through an abrupt transition to remote instruction. However, I am growing concerned with the number of past-due program reviews. The list isn't shrinking as it should be, and we still have documents dating back to 2017 and 2018, which have yet to be turned in. Program review completion is an essential component of accreditation, and it is critical that we complete these reports.

After corresponding with administration, I was told that all **past-due non-academic** program reviews are due by **June 30**. **Past-due academic** program reviews are **due immediately**, and **program instructors who do not submit documents will be denied overloads and special assignments**. Once your document is complete, please email it to me at [jmills@compton.edu](mailto:jmills@compton.edu), so I can forward it to the Institutional Effectiveness Committee for review. The IEC does not meet over the Summer, and I am not on campus working during Summer, so submissions received during the Summer will be scheduled for evaluation in the Fall. If you have questions over the Summer, please consult the attached Program Review Handbook, as I will only have sporadic email communication.

I will be happy to assist authors however I can during that time. **A final note, for academic program reviews due Fall 2020, you should contact Lauren Sosenko in Institutional Research regarding the student survey component asap.
