Keith Cobb reported the Veterans are a sensitive population. He has sent a lot of emails and information, but they don't respond. Keith Cobb said it has been very difficult to communicate with the Veterans, and they are trying their best. It was better when there was a place that they come into. There was more movement when they had a center, but it was shut down. They are trying to focus on how to better reach the students in the spring and with the pandemic, it has been a challenge.

Trustee Ramos asked if the District targets veterans in the district; is there a way to notify them about using their G.I. Bill and what is available to them at Compton College? Dr. Curry stated there is a disconnect between the recruitment of veterans and how we link them to our campus. He said he wanted to do an event last fall for veterans, but then COVID-19 hit. Dr. Curry said the question now is how can we work with the Offices of Veterans' Affairs throughout our communities in order to provide information at those offices about our campus in order to recruit veterans. We need to start to reach out to them to provide that information. In this COVID environment, it has been a challenge for us. We need to do more work on how to reach out to veterans in our community and how to get some leads on potential veterans who want to come back to college. Dr. Curry suggested that maybe a special program can be created for them as we move forward.

Trustee Deborah LeBlanc asked what efforts have been made at Compton College to reach out to get a staffer for Compton College from Compton College, so we can have our own in-house person to further these Green Zone training programs. Dr. LeBlanc also asked how many people are participating, and what are the top two activities that have actually been done to reach out to more veterans. Keith Cobb responded that the main event was the Stand Down event, but that was put on hold.

The only event we had in the fall was the Green Zone training, and the gentleman was a former Compton College part-time professor who moved over to El Camino. We will look into maybe a professor or counselor who is a veteran. Keith Cobb reported that there are 12 veterans who attend Compton College. He stated that for people to attend the Green Zone training, we could only advertise so much. We advertised to the campus and faculty online to get the people that attended. Keith Cobb stated that Dr. Jimenez has mentioned maybe he can work with the Counseling Department to get more counselors involved so when they have face-to-face training with a veteran, they can better understand their mentality and where they are coming from.

Dr. Curry said he will follow-up on Dr. LeBlanc's questions: Who are the speakers; how are they identified; and request to have more in-house speakers from Compton College rather than speakers from other colleges. Also, Dr. Curry confirmed Dr. LeBlanc's request to see numbers of veterans enrolled at Compton College increase. Dr. Curry said he will follow-up and provide an update.

Trustee Barbara Calhoun asked about AMVETS Compton College is working with and reported on several other veterans' resources: there is an AMVETS branch located in Long Beach near South Street. She also reported there is a U. S. Vets located in Inglewood; a Gardena Veterans' Center on Redondo Beach Boulevard at Vermont Avenue, contact Rapheal and the Long Beach Veterans' Center. Trustee Calhoun stated these are all reach-out centers that you can send information to. You could also send information to the Long Beach Veterans' Administration, VFW Posts in different cities (the Compton chapter has meetings on zoom), and the military commissary on El Segundo Boulevard. Trustee Calhoun suggested when having a two-day Stand Down, do not end it on a Sunday, because no resources would be available; try to end on Monday morning so suggested resources will be open.

Dr. Sharoni Little mentioned institutions can receive grants and other monies for veterans, such as for housing and for serving veterans, and asked if we are part of any of those organizations. She asked if we have applied for grants where we can receive money to enhance some of these services? Keith Cobb responded that yes, we do. A small amount is received based on the number of certified veterans we have. He said they received an emergency COVID grant that was issued out to students.

Dr. Little asked Keith Cobb if they partner with any VFW posts. Keith Cobb replied that he has noted that information and will follow-up. Dr. Little asked if there is any type of community outreach initiative where we host local veterans just to acknowledge them as a way to build on this program. Dr. Curry said he will provide an update at the next Board meeting and will follow-up with Trustee Calhoun to make sure that we link to some of her comments about different groups that we should be reaching out to.

Trustee Lopez thanked Keith Cobb for his presentation.

Queen Juarez-Ward thanked Dr. Curry for giving students the opportunity to speak directly with him and stated that is a huge benefit for the students. She further stated that this campus is very important to her and to the other students here.

Commissioner Bruce Boyden was allowed to make comments after the close of the hearing. Commissioner Boyden commented that specifically relating to the reopening and plan for the Child Development Program, that we (we - meaning those in the field of Urban Care and Education) have come to the conclusion that Early Childhood Education programs will never be the same. Given our new circumstances, pre-COVID-19 versus after COVID-19, we find ourselves in the position that when it comes to funding of Early Childhood education, we have been able to hold the line for a while. However, the State funded programs told all of the Early Childhood community that they must re-open by September 7th. The Able B. Sykes Child Development Center did not re-open. The purpose of this process was to explain why they did not. Of course, it was because of the stay-at-home order. However, Commissioner Boyden feels the college is on the right path in making this decision not to reopen because of the safety of the campus and the safety of the children and families which we serve. Commissioner Boyden stated that even though the hearing was closed, he wanted the minutes to reflect his thoughts on the appropriateness of the college's decision.

This is the first Amendment to the agreement, it is in the amount of \$81,000.00 in emergency aid to be administered to Compton College and will increase the maximum approved compensation \$90,000.00 to \$171,000.00. The Period of Performance shall now be extended from April 15, 2021 to June 30, 2021. This amendment will provide emergency grants to students in need to the COVID-19 pandemic. To provide Subscriber with 10,000 licenses to access the Edquity platform for student and administrator use at Compton College. Edquity will intake student emergency aid applications, use its proprietary technology to assess whether to approve or deny these applications for funding and for those students who qualify, use the money in the fund for making direct payments of a monetary amount determined by Subscriber per semester to students as a remedy for student emergencies. Edquity will make a reasonable effort to ensure it can make payments directly to students by June 30, 2021, on behalf of the district for meeting emergency expenses.
