- I) Meeting Called to Order at 2:36 pm
- II) Approval of Agenda: Motion to approve by Steven Gonzales, seconded by Nathan Lopez. Motion passed
- III) Approval of Minutes: Motion to approve by Steven Gonzales, seconded by Stephanie Leonor del Cid. Motion passed.
- IV) **ASCCC training update – Abby Tatlioglu**
  - a) ASCCC has training available online. If you missed a training, ASCCC records all their trainings and can be accessible on their website: <https://asccc-oeri.org/webinars-and-events/>
  - b) These trainings are available for Flex Time.
  - c) California OER Conference is in August. Registration is now open. Presentation submissions deadline is June 6.
- V) **Train the Trainer OER training update – Abby Tatlioglu, Gayathri Manikandan and Malinni Roeun**
  - a) Currently working on developing the OER Retreat. Requesting \$3,000 per person participating to develop OER materials. The Math department is currently training to use MyOpenMath, a free software for faculty and student. The proposal will focus on training faculty to using this specific service. First part, Fall 2022 – every week, faculty will spend two hours training and practicing in M.O.M. and then create ONE course through M.O.M. Spring 2023 faculty use MOM for ONE course to function as a ZTC. 16 workshops for \$1000 incentive for faculty. If 15 faculty participate we could have 15 ZTC sections in Math. This could be a foundation to develop other ZTC STEM courses.
- VI) **Low-Cost Textbook Definition – general discussion**
  - a) **The committee should define what low textbook cost is, as a campus.**
  - b) **Malinni – Is under \$50 considered low?**
  - c) **Mathews – Online CVC will include OER or ZTC listings on their courses.**
  - d) **There needs to be a distinction between low-textbook cost and ZTC. Fifty dollars can be unaffordable**

for many students in our community. \$30 should be considered the threshold for low cost textbooks at Compton.

- e) **Abby Tatilioglu motions to define LTC at Compton College as \$1-\$30; Stephanie Leonor del Cid Seconds. Vote passes by consensus.**

### VII) **OER Website – Nathan & Steven**

- a) Overview of the OER Outline developed by Professor Gonzales and Professor Lopez. The outline considered three major areas to address: Students, Faculty, and a Spanish Language page.
- b) Mathews – Splitting between Students and Faculty so that each entity could find exactly what they're looking for. No new websites will be made as soon as the cutoff. Need to find out when the cutoff date is.
- c) Abby – Include contact information. ASCCC is working on a special project for OER websites. Perhaps a proposal for student videos.
- d) Stephanie – Should consider partnering in ASG to receive funding. The committee will seek on developing this partnership.

### VIII) **OER Workgroup Proposal – Airek Mathews**

- a) The workgroup has completed a draft proposal. The workgroup developed a plan to facilitate the incorporation of OER/ZTC. This would include financial compensation for training, development, remixing, and promotion of OER/ZTC at Compton College. In addition to faculty support, the proposal included information on developing a central database for all of the information regarding OER. Questions from the committee should be sent to Dr. Mathews or Dr. Tatilioglu.
