### 1. Call to Order at 12:34

### 2. Approval of Agenda

- Minodora Moldoveanu noted a correction on adjunct instructor new hire, Samitha Givens. Givens should be noted as the Child Development instructor instead of Shireetha Gethers.
- Essie French-Preston moved to approve agenda. Sean Moore seconded. Unanimous approval.

### 3. Review and Approval of Minutes from December 3rd, 2020

- Jose Villalobos moved to approve. Carlos Maruri seconded. Unanimous approval.

### 4. Reports

#### a. President's Report

- Minodora Moldoveanu announced upcoming vaccinations as well as an upcoming meeting debriefing for the Achieving the Dream survey.

#### b. Vice President's Report

- Carlos Maruri is taking over from Jasmine Phillips as VP and will have a report at our next meeting.

#### c. Faculty Board Representative Report

- Jasmine Phillips is serving as our new Faculty Board Representative and will have a report very soon.

## d. Academic Affairs Report

- Sheri Berger reminded faculty to submit syllabi and encouraged all instructors to do early CRM alerts
- Minodora Moldoveanu and Sheri Berger worked out a schedule to submit to the Educational Policy Advisory Group for approval.

## e. Distance Education Report

- Susan Johnson reported that DE met this week and will be bringing the synchronous camera policy and Respondus 4.0 approval to the Senate at our next meeting.
- DE is offering training on creating accessible course content as well as the Humanizing Online Courses class. See details on the DE page.
- @One will be funded until 2023 through the Chancellor's Office, and Johnson encouraged faculty to take advantage of their courses and seminars.
- CVC/OI has created a virtual community of practice in various disciplines. These are meetings are free and facilitate sharing of course content and best practices.

## f. Faculty Development Report

- Judy Crozier noted that first Book Club meeting of the term is this Friday, 2/26.
- The co-chair position is now open, but Crozier said that Keith Curry has not authorized release time for the position, so it has been difficult to get people to work without pay. Minodora Moldoveanu reported that the position is being submitted to the Board shortly, so this may change soon.

**5. New Business**

Pass/No Pass Notation: Carlos Maruri moved to open discussion. Judy Crozier seconded. Approved.

- Sheri Berger reports that the pass/no pass notation has been allowed up until the end of term for any course, even though some transfer implications could occur. The Senate now needs to consider whether or not to continue our pandemic past practice for the current semester. Discussion followed. The state is considering making the practice permanent. Judy Crozier made a motion to close discussion. Carlos Maruri seconded. Approved.

DE Substantive Change: Jasmine Phillips made a motion to open discussion. Judith Crozier seconded. Approved.

- Amber Gillis explained that this document seeks to demonstrate to the ACCJC that the college is fully prepared to offer distance education per state guidelines and requirements. If we want to continue to offer a substantial number of courses online, the DE Substantiative Change document will allow us to continue to do this.
- There will be a second read at the next Senate meeting. The deadline for completion on our end is April.
- The DE Committee requested the opportunity to go over the document as a group, and Susan Johnson said she would attempt to organize an emergency meeting before the fourth, pending quorum. Michael Van Overbeck made a motion to close discussion. Judy Crozier seconded. Approved.

Proposal from Kendahl Radcliffe for UC Partnership: Jasmine Phillips made a motion to open discussion. Judy Crozier seconded. Approved.

- Kendahl Radcliffe noted that we should present this proposal to the DE Committee prior to addressing the Senate, as it is a DE-driven program. She withdrew the first read to move it to the March 4th Senate meeting. This will depend on whether the DE committee can schedule an emergency meeting prior to the March 4<sup>th</sup> Senate meeting. Jasmine Phillips made a motion to table until our next meeting. Judy Crozier seconded. Unanimous approval.
