MEETING MINUTES

1. Review of Minutes from October 19, 2015 – Approved

2. Accreditation

A. ECC Follow-up Visit scheduled for October 29, 2015 from 10:30 to 11:30 a.m. in the CEO's Conference Room. The subject will be Recommendation #2.

3. 2015-2016 Consultative Council Evaluation

Dr. Curry emailed the Evaluation form to the Council members; feedback due next week.

4. Institutional Effectiveness Partnership Initiative

A. Site visit scheduled for November 5, 2015. Dr. Curry will email information to Council members.

5. Board Policies and Administrative Regulations

The Board Policies and Administrative Regulations Review Schedule was distributed. Board Policy 1200-Mission Statement will be reviewed/discussed in December. Dr. Curry distributed and discussed BP 5550-Free Speech: Time, Place & Manner. He also distributed copies of the possible areas for use (circled in blue). The suggested areas will not disrupt classroom instruction; except the area at the end of Row Building C which can only be used during non-instructional times. Ms. Chua reported that the classroom at the end of building C is usually scheduled. A Facilities Usage form must be submitted and approved prior to use.

6. Other Items

- A. Dr. Curry will host the annual High School Principals' Breakfast on Friday, October 29th. Dr. Subramaniam will make a PowerPoint presentation, "Soaring to Success".
- B. There will be a campus-wide meeting on November 10, 2015 @ 1:00 p.m. in the Student Lounge regarding the Budget, Accreditation, and Facilities.
- C. Dr. Villalobos stated that the faculty has still not received their sick leave and vacation balances. Ms. Perez stated that Mr. Lopez has completed this task; Dr. Curry will send an email to Dr. Villalobos verifying this.
- D. Dr. Curry stated that faculty has not been keeping-up their 33.75 hours or professional obligation and he will discuss this later with Dr. Villalobos.
- E. Dr. Curry reported Student Equity, and SSP – Positions will be added to their programs.

- F. Counseling was discussed – the way services are provided to students; counselors need to be more aggressive in directing student needs.

Mr. Flor suggested case management modeling approach for working with our student population..

Ms. Perez said there should be more internal student outreach; need to be more involved with the Ed Plan Outreach Program.

Dr. Curry said categorical program students receive services, and other students need more help.

Ms. Chua expressed her concern with the length of time it takes to see a counselor. Said there needs to be an “express” counselor, as students have reported having to wait 2-3 hours for service.

Dr. Curry stated that at the start of school the counselors are extremely busy, but at all other times there is easy and quick access to counseling services.
