## 2. President/CEO Items

- A. Compton College Substantive Change Proposal and Open Forum Dates Dr. Curry presented and reviewed the Substantive Change Application and reported that he is working with Jennifer Hill and Dr. Atkinson-Alston to complete this document. He asked the Consultative Council members to review the entire document and make and provide feedback at next week's meeting, or email him with any comments/suggestions.
- 3. 2018-2019 CCCD Tentative Budget Assumptions Dr. Curry reviewed the revised 2018-2019 Budget Assumptions that will be submitted at the April 17, 2018 board meeting. Dr. Curry shared his concerns that in the 2023/2024 year the District will lose \$3.5M in state funding; can set aside money from reserve of \$1.8M to cover costs. Consultative Council supports this recommendation. There is still money in the Line-of-Credit, but he is hesitant to use this because we don't know what else is coming in the future. Dr. Curry will update this document for the next meeting. He is also concerned with the additional cost of salaries for campus police, and is inviting Police Chief Trevis to make a presentation at the April 30, 2018 meeting.

    - Mr. Flor is concerned with how to accommodate college hours so more faculty members are able to participate on campus committees.
    - Dr. Curry asked which committees should discuss this. There was a suggestion that the Enrollment Management committee should discuss the schedule.
