# **MINUTES**

#### 1. Review Minutes from November 14, 2018 - Approved

#### 2. President /CEO Items

Dr. Keith Curry announced that the Compton College Holiday Party would take in the Student Lounge. Walter Brown mentioned that on December 12, 2018, the Associated Student Body would be having an artificial snow machine event. Dr. Keith Curry said that he does not have any problems with the event, but does have concerns about the safety of other people, so just make sure that the artificial snow machine event is in the grass areas outside of the Student Lounge area.
