**1. Review Minutes from August 15, 2022**

- A. Lauren to talk about Annual Planning Cycle at next meeting. Lauren asked to also share recommendations on the Compton College Equity Plan.
- B. No changes to the minutes.

**2. President/CEO Items**

- A. COVID-19 Update
  - i. Heather Parnock – Heather and Barb Perez will be presenting a draft of a Remote Work Board Policy, Administrative Regulation, and Request Form to Deans and Directors on Thursday. It will then go to the Health & Safety Committee in September, then back to Deans and Directors in October. Pandemic Coordinators are reviewing the Pandemic Emergency Operations Plan and making note on what needs to be updated.
  - ii. Dr. Keith Curry said that we need to continue to wear masks and promote the wearing of masks to students and others on campus.
  - iii. Paul Medina asked for clarification on the mask wearing policy. Heather replied that it is mandatory inside unless you are alone, and a mask is not required outdoors.

- C. Debriefing on Welcome Week Activities

- A. Dr. Abdul Nasser reviewed the Budget Assumptions document. Barb recommended updating the job title for the Business Analyst and will send Dr. Nasser the updated job title. Dr. Curry concerned and doing research on the categorical funds in the state budget for this year. We need a better understanding of the dollars and deadlines so we can maximize the dollars.

There is one application for Student Trustee. Dr. Moldoveanu asked if there was a student representative assigned to the Academic Senate meeting. Paul said he would commit to attending that meeting and requested the meeting invite.
