MINUTES

1. Review minutes from September 27, 2021 – Approved

2. President/CEO Items

A. COVID-19 Update -

Dr. Curry reported the COVID-19 vaccination is mandatory effective October 1, 2021. Andrei Yermakov has created a do-not-enter list of employees and students, which is used at the front entrance, showing who is not allowed on campus.

Dr. Curry recommends a \$200 incentive for students to receive the vaccination should be offered and a \$200 incentive for student-athletes who got vaccinated this semester. January 1, 2022, for students who have received the vaccine; then any student vaccinated January through spring would receive the \$200.00 incentive. The Financial Aid Department would disburse the vaccine incentive. Dr. Curry suggested creating a Student Vaccine Incentive Taskforce, including two managers/supervisors, three students, two faculty, and two Classified Staff representatives.

3. Associated Student Government - Tartar Mascot Review Recommendation Committee

Dr. Moldoveanu said she would have the names of representatives by Friday. Stephanie Leonor Del Cid noted there are three new members to ASG, and they have been asked if who would like to participate. Dr. Curry said he would like to have feedback on the process and members' names by *Friday, October 8, 2021*.

4. Draft Equity Definition:

Christine Aldrich reported the Deans and Directors had reviewed the Student Equity Statement and Managers, and feedback will be shared with this committee. Below is the draft Student Equity Statement:

"Equity refers to achieving parity in student educational outcomes, regardless of race and

ethnicity, background, or identity. Compton College identifies and removes barriers that produce inequity and intentionally design new or refined services to provide each student with what they need to be successful in their college experience. Compton College students actively define needs and solutions to equity problems on the campus. Equity processes ensure that all people have the opportunity to engage and succeed in a high-quality educational experience and all students have tools to support their academic career and personal goals."

Dr. Curry stated that edits should not be made until all feedback has been received. How to get feedback from students was discussed. Dr. Curry asked Chris Perez to meet with ASG then send him their recommendations within the next two weeks on how this process can be improved. Dr. Moldoveanu will send information on Academic Senate meetings to Stephanie Leonor Del Cid so an ASG report can be provided during the senate meetings.

Chris Perez commented that some students participate in committees because of their availability but are not sure why they were invited, or they have not been prepared on what the meeting is about, or why it is essential. The student may not understand how to share out or may not understand the language and acronyms being used. Chris Perez suggested having committee mentors who would give the student orientation and provide information on what is being talked about, what is on the agenda. The documents are mentioned, so they understand what the conversation is about and can provide informed information feedback.

Stephanie Leonor Del Cid commented that she thinks students need to be clear on what they expect on these committees. Christine Aldrich agrees that we need to be clearer on what we want the students to provide feedback. Dr. Curry instructed Chris Perez to meet with ASG within the next two weeks to discuss this and send him their recommendations on how to improve this process.

Dr. Moldoveanu asked about the disbursement of student financial aid and a lock-in date. Dr. Curry responded that this lock-in date is required and is usually right after the census date. Dr. Curry said he asked Keith Cobb to provide additional information on the lock-in date.
