**Minutes**

February 12, 2019

- Committee member requested to correct item number one and two from Decembers Minutes.
- Committee members are requesting to participate in the next CPR/First Aid Training Course Schedule for April 2019. Waiting on VP of HR response. In progress.
- Committee Members also indicated that Captains in the SRC Lab need evacuation training as well. Several floor captains did receive lift-chair training and committee members are requesting new floor captains to receive the training.
- Committee Members were informed that as of today February 12, 2019, Detective Cervantes would be taking over the Health & Safety Meetings.
- Committee Members were informed that new multi-level buildings have designed new safety points installing concrete bollards in front of the buildings to prevent car injuries. Chief Box will be discussing having this type of safety equipment on our campus. Health-Safety and Parking Committee members will be tasked with identifying possible hazard areas on campus and making recommendations to the Facilities Committee.
- Committee Members was informed that the Vocational Technology Building has an infestation of mice, and all employees in the building was reminded not to leave any food out. Committee Members also requested CalWorks Office be inspected for best practice as it relates to storage. Employees are reporting common areas are too cluttered with supplies creating a welcoming

environment for rodents and other pest.

- Committee Members were informed that no additional parking stalls are available at the moment in Lot A. Students proposed to have a passenger drop off zone near the Tartar Village that would allow them to drop off heavy equipment and other class material. All recommendations are being forwarded to administration for review.
- Committee Members were informed that our homeless population on and near Compton College has almost quadrupled in number in the last six month. Please lock your respected areas at the end of the day, and do not hesitate to contact campus police if you notice anything suspicious on campus.
- Committee Members were informed that the construction project has started and Rows F & G are blocked now blocked off. A couple of very old trees were also removed from the area.
- Committee Members were informed that the traffic light installation on the intersection of Artesia & Main Campus Drive request was approved by the city of Long Beach last year. However, the city does not have a time line regarding the installation.
- Calls were made to the cities of Compton and Long Beach public works departments regarding potholes on Artesia Blvd.

**Committee Members Concerns:**

- Committee Members (Faculty) are requesting to have Room 103, 110, & 128 be inspected as soon as possible due to the bad odors coming out of these classrooms.
- Committee Members called the City of Long Beach & City of Compton to report big potholes located on Susana Road & Artesia Boulevard that are extremely dangerous especially at nighttime.
