Meeting Minutes from February 2018

Committee members are requesting repairs be made to several classrooms in the MS Bldg. labs. Problems discussed include the fact that several lighting fixtures are not working and need to be replaced. Electrical outlets on the floors are old and eroded which has caused them to become detached from the surface leaving holes in the floor that may cause injuries to staff and students. Faculty and staff are requesting more inspections and visits by maintenance supervisors.

Committee members reported that restrooms inside the Math and Science Building are often not stocked with paper towels, soap or tissue. Faculty members have complained that they are personally buying supplies to maintain classrooms and often times have to take out their own trash because there is no regular trash removal. WO#88620

Committee members are requesting that the slippery floor tile in the SRC be replaced with non-slip carpet, as the chairs have wheels that tend to slide out from underneath the students when they are attempting to stand, presenting a high risk for injury. WO#88619

Committee members are requesting a Campus Wide "Clean-Up Day where Participants can help clean up their favorite areas on campus. This is meant to Be a volunteer project. Logistical recommendations will be forwarded to the Office of the CEO for April of 2018.

Committee members would like to be included in the next CPR / First Aid Training Course that is held here at the Compton College Campus.

Committee members would like to see a printed map of all District Restrooms that have been converted to unisex restrooms in accordance With AB1732 bearing the signage recommended by the Committee.

Committee members have received several complaints that M&O personnel on campus are entering classrooms in session and removing recyclables while leaving the trash behind. The matter has been reported to M&O management for resolution.

Committee members discussed the fact that during the last Great Shake-Out Drill there were several faculty members that did not participate as required. The HSP Committee Chair and Co-Chair will address those known faculty members who failed to participate. The next Great Shake Out Drill is planned to take place in April 2018.

Committee members will be trained by one of our members regarding Outdoor Emergency Care which will be useful in the event of an emergency.

Committee members received complaints regarding a high volume of insects in various locations on campus. M&O brought in Pest Control in November of 2017 and they were assigned to mitigate the issue. (resolved)

Committee members were advised that in an effort to reduce slip and falls On campus, the tiled portions of our walkways on the east side of campus have been re-cemented in place. (resolved)

Committee members are proposing the creation of a spreadsheet that can be used to document and track work done in each bldg. by the maintenance personnel. Several restrooms on campus seem to lack daily service.
