



Compton College Students - Student Survey to Inform Spring 2022 Scheduling November 15, 2021

In fall 2021, Compton College surveyed all students currently enrolled at Compton College (n=4,365). The survey that was administered by Qualtrics received 467 responses resulting in a 11% response rate. These results should be considered when planning for the spring 2022 term; however, these results should be interpreted with caution based upon the low response rate and the specific student population. This survey sought feedback from students who are currently enrolled. The college is looking to reengage students who have left the college during the pandemic in addition to those who are currently enrolled. The students who have left the college are not represented in these findings. This limitation should be considered when interpreting results.




What classes are you currently taking at Compton College? Check all that apply.




## Have you been vaccinated for COVID-19?




#### What are your plans related to the vaccination?



Which of the following challenges or issues do you currently face in completing your coursework? Check all that apply.




Please indicate your level of agreement for the following statements about your perception of Compton College's ability to bring students back to campus and your attitudes about safely returning to campus.



Please rate your level of fear related to COVID-19 infection: My level of fear about contracting COVID-19 myself:




My level of fear about carrying the virus home to family members:


I'm not comfortable in person class I perfect online instruction. Many people still not vacated.


