- 2. SLO Completion has significantly dwindled
 - a. SLOs/PLOs distributed to those present by GPD
 - b. 36 / 413 SLOs have been completed as of 1/10/2020 (approximately 9%)
 - c. Facilitator / Coordinator positions have applications for review
 - Committee believes filling these positions will be vital for improving completions
- 3. Assessment tool development
 - a. Tool should be utilized by ALL GPDs
 - b. Data collection method?
 - Survey
 - Faculty Checklist (demographics from Banner)
- 4. Review process for SLOs/PLOs
 - a. In the past the college has utilized:
 - Brown bags
 - Dept Meetings / SLO/PLO meetings at the beginning and end of the semester
 - b. Brown bags and Dept meetings were the exception
 - "Faking Data" was rampant
 - c. "Old" Process was more accountable
 - Instructors were required to turn in their raw data and write an action plan
 - d. How do we return to accountability and participation
 - Faculty needs constant reminders to complete
 - Reminders need to come from faculty
 - e. Consequences for not completing
 - Those that don't complete are ineligible for "overload" but still able to be full time
