AGREEMENT BETWEEN

COMPTON COMMUNITY COLLEGE DISTRICT

AND

GENE J. FARRELL

THIS AGREEMENT is between Compton Community College District (hereinafter "District") and Gene J. Farrell (hereinafter "State Special Trustee") and provides:

- 1. The District will employ Gene J. Farrell as the State Special Trustee for Compton Community College District effective May 10, 2017. Mr. Farrell has been appointed as the State Special Trustee by the Chancellor for the California Community Colleges (State Chancellor), and shall serve in that capacity at the pleasure of the State Chancellor. Mr. Farrell shall be paid \$4,000 per month.
- 2. The first billing will be made on June 1, 2017, for services in May 2017 and continue monthly until the assignment is completed. Payments are to be made to:

- 3. Under the direction of the State Chancellor, the primary responsibilities of the State Special Trustee are to maintain fiscal stability/solvency by enforcing the "principles of sound fiscal management," obtain accreditation from the Accrediting Commission for Community and Junior Colleges (ACCJC) for the El Camino College Compton Center, and assist with the transition of the El Camino College Compton Center from El Camino Community College District to an accredited and recognized college within the Compton Community College District. The Special Trustee's duties will include:
 - A. Working closely with the State Chancellor, the boards of trustees and CEOs of the Compton and El Camino Community College Districts, and representatives of the ACCJC.
 - B. Reviewing, monitoring, and requiring modifications to the fiscal and educational plans deemed necessary in order to maintain fiscal stability, obtain accreditation, and ensure state emergency funds are properly administered.
 - C. Determining and requiring appropriate district spending levels and priorities, to insure that the district's fiscal stability and accreditation standards are secured.
 - D. Ensuring compliance with the standards and requirements of ACCJC.
 - E. Ensuring compliance with the Partnership Agreement between El Camino Community College District and the Compton Community College District.
- 4. The State Special Trustee will be required to attended monthly Compton Community College District Board meetings and will have "Stay and rescind" authority (or such other authority as the State Chancellor shall designate in writing) over the elected Compton Community College District governing board when board action is

inconsistent with the fiscal and accreditation recovery plan for Compton Community College District and the El Camino College Compton Center.

- 5. When the District requests in writing that they wish State Special Trustee to attend an educational conference, the District shall reimburse State Special Trustee for necessary transportation, meals, lodging, and registration fees for such conference in accordance with existing District policy and regulations.
- 6. The State Special Trustee agrees to defend indemnify and hold harmless the District and its officers, agents and employees from and against all claims, damages losses and expenses, including but not limited to attorney fees arising out of or resulting from the State Special Trustees performance of this Agreement, which are not caused by District negligence, willful misconduct or lack of good faith.
- 7. District agrees to defend indemnify and hold harmless the State Special Trustee and its officers, agents and employees from and against all claims, damages, losses and expenses, including but not limited to attorney fees arising out of or resulting from the Districts performance of this Agreement, which are not caused by State Special Trustees negligence, willful misconduct or lack of good faith.
