1. Resolution to Continue Remote Instruction Until Fall 2022. ***Received.*** The resolution is aligned with how winter 2022 and spring 2022 are currently scheduled. For winter 2022, 17 sections out of 102 sections (16.7%) of classes are scheduled remote/synchronous. For spring 2022, 74 sections out of 519 sections (14.3%) of classes are scheduled remote/synchronous.
2. Resolution for New Financial Aid Policy at Compton College. ***Received.*** I have asked the Director of Financial Aid to propose a revised date for what works within the Financial Aid Office. While I agree that we need to change the date, I need to ensure we can award students financial aid based on the set date.


