Suggestions: 1.) Have a process in place that ensures ALL faculty are REALLY actively participating in the committees, not just simply writing their name on the committee lists so that they can claim to be committee members. Being a committee member should mean regular attendance, participation in tasks, and getting results that are visibly beneficial to CEC students and/or center. 2.)All chairs should have an annual short feedback sheet for administrators to review regarding attendance and participation of the members. It does not have to be in-dept, perhaps just a check-off sheet to ensure active participation not just "in-name" only membership. 3.)Chairs should "purge" members, like students, who do not attend and have no legitimate reason for for their non-attendance. Faculty who are not active members must be encouraged to participate/choose another committee to fulfill their professional obligation. 4.)Any club advisors, committee chairs, or leadership roles should be held accountable for actually holding regular meetings and showing some benefits to students/faculty, ie produce announcements, agendas, minutes or any legitimate documentation to validate their existence and benefits. 5.)Have a newsletter in which clubs, committees, organizations, entities communicate their happenings to campus-wide community.
