Accelerated Evening/Weekend College Program

In response to the action item from the Enrollment Management Plan, with documented progress in <u>Progress</u> and <u>Completion, Item 7 from the Action Plan</u>, the Academic Affairs Deans, in consultation with the Division Chairs and Vice President Sheri Berger, proposed an Accelerated Weekend/Evening program. The program will commence in the fall of 2023. Classes will be scheduled one weeknight and one Saturday in eight-week sessions. The program plan will ensure students can complete the AA-T in Psychology in two years, taking two classes per term and three asynchronous general education classes during winter and summer. To ensure support for the program, I approved their proposal of \$36,200 per year to cover the cost of outreach and recruitment material, overtime for Classified staff support, adjunct counseling hours, and engagement activities. Affordability, Food & Housing Access Taskforce Report

In preparation for the upcoming Legislative Conference, the CCLC released a new brief by the CEO Affordability, Food, and Housing Access Taskforce: Deepening the Commitment to Affordable Student Housing. This new policy brief congratulates the Legislature and Governor for making a serious commitment to housing access for CCC students while making several important policy recommendations for the state system. Highlights include:

- Advocating for the state to stay committed to funding that is already budgeted for planned housing projects as colleges build out their designs for more housing
- Stressing the need for additional funding in future budget years to address the pent-up demand for affordable student housing across the state
- Supporting technical changes to existing laws to allow for plan review at either the local level or by the Division of State Architect
- Endorsing the use of state-scheduled maintenance funding for housing repairs to help colleges maintain their housing stock over time
- Changing scoring criteria to incentivize the construction of family housing in recognition of the demand within our colleges that goes beyond the typical conception of a college student
- Leveraging housing on our campuses to address the food insecurity issues that our students face

President/CEO Closing the Loop

The Petitions Exception Committee (PEC) composition and purpose have been approved. This committee is being established to address the occasional warranted exception to policy or procedure. The committee will

create a petition submission process, establish guidelines and procedures, and communicate the decisions as needed to those impacted. The PEC will review the following.

- Excessive Course Repeat (4th attempt only) Students petition to repeat courses for a few different reasons, including fourth attempts for extenuating circumstances.
- Drop a Course with No Record Students petition to drop courses with no record and a refund to ensure an evaluative grade or a "W" is removed from their academic record, along with a refund of tuition fees. Students might be eligible to drop a course with no record if they stopped attending by the 10% drop deadline. Per Title 5, California Code of Regulations, no exceptions are allowed for removing a grade if attendance was beyond the 10% drop deadline.
- Excused Withdrawal Excused withdrawals are drops processed with an EW evaluative symbol for extenuating circumstances. Excused Withdrawal(s) shall not be counted in progress probation, dismissal calculations toward the permitted number of withdrawals, or counted as an enrollment attempt. Petitions can be submitted during or after the current semester.
- Priority Enrollment Students petition for priority enrollment when they have lost priority due to 90+ units or probation status. Each student is assigned an enrollment 'appointment,' which represents the day and time that registration opens to that student online or in person. Compton College sets enrollment appointments based on guidance from Title 5 Section 58108.
- Withdrawal After Deadline Students petition to retroactively withdraw after the 75% deadline to have an evaluative grade (letter grade) replaced with a "W" withdrawal. Documented extenuating circumstances may be eligible for an "Excused Withdrawal." All requests for a grade change from an evaluative symbol to a "W" (Withdrawal) or No Record must be made within 18 months of the date when the grade was posted and initiated by the
- Overload Exceptions Students who do not meet the Overload unit and GPA requirements would like special consideration for Overload approval. Petitions must be signed/approved by a counselor and include a statement or supporting documentation related to the reason for approval consideration.
- Other student petition requests include but are not limited to: refund of fees related to COTOP, non-resident, health services, student activities, etc., and other appeal requests.

The PEC will consist of representatives from the following groups: one Classified staff member representing all categorical programs (EOPS, CalWORKS, SRC, etc.), Admissions and Records, Academic Affairs (dean), instructional faculty, and counseling faculty. The Petitions Exception Committee will be chaired by Richette Bell, Director of Admissions and Records.

Final Thoughts

In closing, for the last three years, we have been dealing with the COVID-19 pandemic, declining enrollment, student completion rates, student basic needs, student and employee mental health challenges, construction (i.e., Student Services Building), and other essential matters. However, these challenges have not stopped our excellent work for our students and the communities we serve. I hope everyone is proud of our work and looks forward to the spring 2023 semester.
