Winter 2024 Enrollment Update

As of *yesterday, November 2, 2023*, Compton College has generated 118 FTES for the Winter 2024 term. Our fill rate for Fall is currently 36%, and seats filled are 1,057.

Draft 2023-2026 Equal Opportunity Plan

A draft of the [2023-2026 EEO Plan](#) has made its way through the Compton College Collaborative Governance Process. It has been submitted to the California Community Colleges Chancellor's Office for a 90-day review. This review will help us ensure that our plan complies with the new regulations. The Compton College Board of Trustees has been provided a copy of the [draft plan](#). Per the new regulations, they will be reviewing the feedback we receive from the Chancellor in early Spring 2024 before taking action to adopt the three-year plan. The plan focuses on both diversity and recruitment efforts to continue to support and build on our existing goals in these areas. Stay tuned for updates about the status of the plan. 2024-2025 Annual Plan Updates and Training

It's time to prepare for the 2024-2025 annual planning process. There are some significant changes regarding this year's process, so please review this email closely and reach out with any questions.

For the 2024-2025 planning cycle, we will be transitioning from the Excel and Word logic model templates for submitting recommendations to submitting recommendations in eLumen. eLumen is the platform we already utilize for our program review and SLO assessment processes. Managing annual planning along with these two activities in a single platform will support our efforts to continuously integrate program review, planning, and resource allocation into a comprehensive process. This is a necessary first step that will enable us to link resource requests to specific student learning and institutional outcomes and will help us better evaluate the effectiveness of our activities and initiatives.

To support you in this transition, the Institutional Effectiveness Office will offer training sessions beginning next week through the rest of the semester (spring semester training is TBD). 2023 Chaptered Legislation and Guidance Report

The California Community Colleges Chancellor's Office is pleased to release the [2023 Chaptered Legislation and Guidance Report](#). This serves as an official notice to districts of all new laws approved by the Legislature and signed by the Governor in 2023. The Chaptered Legislation and Guidance Report (coming soon) was developed as a resource for campuses to inform them of recently enacted laws related to the California Community Colleges so that they take the necessary steps to implement them. Following the law, it is incumbent upon local leadership to ensure compliance with all new laws and regulations. Do not wait until the Chancellor's Office issues memos and guidance for bills before taking the necessary steps to become aware of, prepare for, and work toward compliance. Many of these bills bring new opportunities for students, faculty, and staff. Failure to comply and inform constituents of these new laws could result in inequities and missed opportunities.

To support colleges with implementation, the Chancellor's Office has included information and preliminary guidance for each bill. Where appropriate, follow-up guidance and supporting materials will be made available to colleges. This report will be updated monthly through March 2024 with available guidance.
