As of *yesterday, March 28, 2024*, Compton College has generated 1,437 FTES for the Spring 2024 term. Our fill rate for spring is currently 64%, and seats filled are 10,254.

Senate Bill 895 (Roth) - Community Colleges: Baccalaureate Degree in Nursing Pilot Program

I submitted a <u>letter of support on behalf of the Compton Community College District to the Honorable Josh</u> <u>Newman</u>, chair of the Senate Education Committee. <u>Senate Bill 895</u> would address California's nursing shortage by authorizing 15 California Community Colleges to award Bachelor of Science in Nursing (BSN) degrees. Senate Bill 895 bridges the nursing gap in the State by utilizing existing Associate Degree in Nursing (ADN) programs at community colleges to address the lack of capacity in public, four-year nursing schools. With the difference between an ADN and a BSN being only an additional 30 units of upper-division major coursework, several ADN programs are well-positioned to expand their offerings to BSN degrees.

Compton CCD Update on the Repayment of its Emergency Apportionment Funding

On *March 26, 2024*, I sent a <u>letter to the Senate and Assembly Budget Subcommittees</u>, as well as the <u>Department of Finance</u>, providing a revised plan for repayment of our Emergency Apportionment loan balance. The Compton CCD now anticipates making the final payment to the Department of Finance in Fiscal Year 2026-2027.
