Today, California Governor Gavin Newsom released the May Revision proposal for the 2024-2025 fiscal year that ensures the budget is balanced over the next two fiscal years by tightening the state's belt, stabilizing spending, and also preserving key ongoing investments. According to California Community Colleges Chancellor Sonya Christian, the budget proposal includes significant spending reductions for many state services but largely protects the California Community Colleges.
