Subject: President/CEO Message -November 22, 2024

Campus Community,

I know it's not a huge success, but it's considered a win since we have been unable to communicate with current students via email and text message for quite a while. As mentioned in the [President/CEO Message - October 25, 2024](#), we were experiencing issues with the Ellucian Banner CRM Advise platform. We are pleased to report that the Student Services Division Office, specifically the Educational Partnerships Department, has resolved the majority of issues with the system's email/text message functions.

We successfully tested the system last week with a winter/spring registration reminder. The communications can be tracked, showing the number of successes and failures, and automated to resend to those who didn't open the email. In the case of the winter/spring email, only one failure was reported, and 3,710 text messages were sent, with a 6% click rate within one day.

Additionally, the workgroup continues to meet with the Ellucian consultant, along with the categorical programs, to identify their specific cohorts of students and streamline personalized communications. This collaboration helps categorical programs enhance their communication workflows with their specific target audiences.

On *Tuesday, November 19, 2024*, we celebrated the grand opening of Instructional Buildings 1 and 2. These modern facilities mark a significant milestone in our campus transformation, providing state-of-the-art spaces designed to support the growth and evolving needs of our students, faculty, and staff. The new buildings, part of our "Academic Village," replace outdated structures and enhance campus flow, symbolizing our commitment to innovation and excellence in education.

We extend our heartfelt thanks to the community for their unwavering support, which made these projects possible through the approval of the 2014 Measure C facilities bond. These buildings, featuring advanced smart classroom technology and sustainable design, will serve as the foundation for learning, growth, and innovation for many years to come. Thank you to everyone who contributed to making this vision a reality.

Summer and Fall 2025 Enrollment Update

As of *yesterday, November 21, 2024*, Compton College has generated:

- 232 FTES for the **Winter 2025** term. The fill rate is currently 68%, and the seats filled is 2,047.
- 538 FTES for the **Spring 2025** semester. The fill rate is currently 22%, and the seats filled are 3,556.

Holiday Health Reminder

As we approach the holiday season, we want to remind everyone to stay safe and healthy. Here are a few important tips:

- **Stay Up to Date with Vaccinations:** Ensure you and your loved ones are vaccinated and have received any recommended boosters. The [St. John's Student Health Center](#) (M4, north of the gym) has flu and COVID-19 vaccinations available for students and employees.

- **Wear Masks in Crowded Indoor Settings:** Masks can help reduce the spread of COVID-19, especially in crowded or poorly ventilated areas.
- **Practice Good Hygiene:** Wash your hands frequently and use hand sanitizer when soap and water aren't available.
- **Monitor Your Health:** Before returning to campus, please check for any flu-like or COVID-19 symptoms. If you feel unwell, stay home and seek medical advice.
- **Free Test Kits Available:** Free at-home COVID-19 test kits are available while supplies last at the St. John's Student Health Center for students and in the Human Resources Office for employees.
- **Report Positive COVID-19 Cases:** The "[Report a Positive COVID-19 Case](#)" form is available via the MyCompton portal and includes questions necessary to determine quarantine and isolation guidelines and assist with contact tracing.

Annual Chancellor's Office Tax Offset Program

The [Chancellor's Office Tax Offset Program](#) (COTOP) helps colleges collect outstanding debts from former students who are no longer enrolled and not seeking college services. Compton College students with outstanding balances will receive a letter informing them of their debt and have 60 days to resolve it by either paying or disputing it if they believe there is an error. A second reminder will be sent 30 days from the date of the initial letter. If the debt is not resolved within 60 days, the student's information will be submitted to the California Franchise Tax Board (FTB) for collection, which can intercept state tax refunds, lottery winnings, and unclaimed property to recover the debt. An additional 33.3% administrative fee will be added to the debt if it is submitted to the FTB. California's Sanctuary Status and Its Impact on Our Community

California's sanctuary status, established under [Senate Bill 54 \(SB 54\)](#), limits the cooperation between local law enforcement and federal immigration authorities. This policy aims to protect undocumented immigrants by ensuring they can access public services and report crimes without fear of deportation.

The sanctuary policy is designed to foster trust between immigrant communities and local authorities. It ensures that undocumented immigrants can seek help from police, access education, and utilize healthcare services without the fear of being reported to immigration authorities. SB 54 restricts local law enforcement from using resources to aid federal immigration enforcement, except in cases involving serious or violent crimes. This ensures that local resources are focused on community safety rather than immigration enforcement.

By understanding and communicating these points, employees can better support our undocumented students and community members, ensuring they feel safe and valued. The California Community Colleges Chancellor's Office has updated past guidance regarding California's sanctuary status and its impact on our community. Compton College provides information and support to undocumented students through resources like the AB 540 program, which helps eligible students access in-state tuition and financial aid. Update on Immigration Policy Response

Considering the potential of the new White House administration implementing immigration policy reform in 2025 and the existing provisions of Senate Bill 54, Compton College is moving forward with responses to these anticipated changes:

- **Legal Guidance:** We have engaged Liebert Cassidy Whitmore's law firm to advise the district on the potential new administration's immigration policies and assist with potential responses, which may include reviewing and/or developing Board Policies or Administrative Regulations, providing professional development for faculty, Classified Professionals, managers/supervisors, and creating communication documents for students and employees.
- **Taskforce Meeting:** I will attend the next UndocuAlly Taskforce Meeting on *December 3, 2024*, to discuss concerns and seek creative input on the next steps related to the anticipated new administration's immigration policies.
- **Communication:** Ensuring timely communication to the campus community regarding new federal and state immigration policies and our responses.

We are committed to ensuring our campus remains a safe and supportive environment for all members of our community. More information will be included in future President/CEO Messages.
