# Campus Community,

As we enter the final stretch of our summer term—with the 8-week and 2nd 6-week classes concluding on *August 14, 2025*—I would like to thank you for your continued commitment to our students. Now is a critical time to help students stay on track and finish strong. Whether through academic support, timely communication, or simply reinforcing expectations, your efforts make a difference.

This week, I had the opportunity to attend the 5<sup>th</sup> Annual California Association of Black School Educators (CABSE) Institute, which brought together educational leaders from across California and nationally to focus on equity, innovation, and student success, particularly for Black students. The conversations and strategies shared there reaffirmed the importance of the work we're doing at Compton College to remove barriers and create opportunities for all students.

At the CABSE Institute, I participated in a national panel on food insecurity coordinated by Kroger Foods. As mentioned in the <u>President/CEO Message – May 30, 2025</u>, we are finalizing a new partnership with Kroger to support Compton College in addressing food insecurity. With the approval from Kroger Foods, I was able to announce the partnership at the CABSE Institute. We plan to present the proposed Memorandum of Understanding between Compton CCD and Kroger to the Board of Trustees for approval on *August 18, 2025*.

The Compton CCD and Kroger partnership will focus on:

- Weekly donations of non-perishable (and when available) perishable foods for our Food Pantry.
- Additional food donations for departments and faculty who wish to provide snacks or meals to students.
- Joint planning of campus and community events to address hunger in the Compton CCD.
- Long-term planning for a new Food Pantry space in the future Basic Needs Center, as outlined in the Compton College 2035 Comprehensive Master Plan (please see page 95).

More details will be shared in a future <u>President/CEO Message</u> and at the Fall 2025 Professional Development Day, scheduled for *Thursday, August 21, 2025*.

Thank you to everyone who provided creative input regarding this partnership, and to the Compton College Support Network for all their work in addressing our students' basic needs. Let's continue working together to ensure every student can succeed. Thank you for all you do.

### **Enrollment Update as of July 17, 2025**

- 531 FTES for the **Summer 2025** term. 4,447 (78%) of the available summer seats are currently filled.
- 1,018 FTES for the Fall 2025 semester. Our fill rate for fall is 41% with 6,804 seats filled.

As always, I am concerned about enrollment; however, I am taking into consideration the Suspected Fraudulent Student Accounts from fall 2024, which were discussed in the <u>President/CEO Message – August 30, 2024</u>. Additionally, we are still processing applications for dual enrollment for fall 2025. We must continue to remind students to register as soon as possible. And, as always, encourage them to take a full course load if possible—it's one of the best ways to stay on track for graduation or transfer.

### Marketing/Advertising Update for the Fall 2025 Semester

A community newsletter is being developed to launch the career education marketing campaign, which includes social media ads and targeted emails to stop-outs and prospective students who have applied to Compton College but never registered for a class. The newsletter will be mailed in mid-August 2025 to all in-district residents. A new Oliver W. Conner College Promise Program flyer, available in both English and Spanish, is currently in development. Next week, a <u>postcard</u> will be mailed to Class of 2024 Compton Unified School District and Lynwood Unified School District high school graduates who did not enroll in any college, encouraging them to consider Compton College and to RSVP for the <u>August 20 New Student Welcome Day</u> event. A new contract with the DMV will renew our video ads at the Compton and Gardena locations this fall, and additional digital and print ads will run through *September 2025*.

#### **Student-Centered Success Milestones**

As part of our ongoing efforts to strengthen Guided Pathways at Compton College, Dr. Darlene Zarazu, Director of Educational Partnerships, and Dr. Maria Garcia, Interim Dean of Counseling and Guided Pathways, have been working to revise and update the Milestone Plan for Success Teams. These milestones, currently in draft form, are designed to serve as a shared framework that supports intentional, equity-minded student support and coordination across departments. The goal is to outline key actions and goals to help streamline efforts, improve communication, and create more consistent and supportive experiences for our students. Ultimately, these milestones have the potential to positively impact student persistence, retention, and completion by ensuring that each area contributes to a cohesive, student-centered pathway.

We are seeking your input to make sure the current draft of the plan accurately reflects the work in your area and aligns with our institutional priorities.
