Important Reminders for Financial Aid Recipients

WHAT IS REQUIRED OF YOU:

- Complete or renew a FAFSA each year beginning January 1st. Financial Aid considers it late after March 2nd.
- Maintain a GPA of 2.0 or higher.
- Complete 67% of your cumulative attempted units.
- Complete 67% of your term's attempted units if you are on a Lock in List.
- Do not exceed 90 attempted units.
- Develop or update an education plan every year.
- Submit all required documents to the Financial Aid Office as soon as possible.
- Declare a major in Admissions and Records.
- Update any address changes in Admissions and Records or online.
