

February 21, 2025	First 50% disbursement of Federal Pell Grant.
March 14, 2025	Disbursement of SEOG, Cal Grant A-SWD, B, & C, and Federal Direct Loans for
	<u>returning</u> student borrowers.
	Second 50% disbursement of Federal Pell Grant (continuing every Friday
	thereafter).
	Federal Direct Loans for new first-time borrowers will be disbursed 30 days after
	the start of their classes.
May 2, 2025	Disbursement of Student Success Completion Grant (SSCG).
General Disbursement Information	
Application of Funds:	Disbursement are applied to outstanding tuition/fees first.
	Refunds are issues if aid exceeds charges.
	Student must pay any remaining balance if aid is less than owed.
Unit-Based Disbursement:	Aid disbursement is based on the number of enrolled units at the time of
	Not all financial aid funds (e.g., California College Promise Grant) are disbursable.
Electronic Refund Options:	Students receive a Refund Selection Kit via email and mail.
	Refund preferences must be set at BankMobile Disbursements.
Tracking Disbursement	
Timeline:	Disbursements start Wednesday before the first week of the semester.
	Processing refunds takes 5-10 business days (excluding weekends/holidays).
Account Updates:	Students see a negative balance in MyCompton when processing begins.
	Negative balance disappears after funds are transferred to BankMobile
	Disbursements.
Notifications:	Students who set up for BankMobile notifications receive alerts when refunds are
	deposited.
Transfer Monitoring:	Aid disbursement may be delayed (up to 10 days) for verification of non-
	duplication of aid at other colleges.
Eligibility Requirements	
Minimum Enrollment:	Students <u>must</u> be enrolled in at least 6 units to receive a disbursement of Federal
	Direct Loans, SEOG, and A-SWD, B, & C.
	If a student is enrolled in less than full-time status (12 or more units), the student's
	aid may be prorated accordingly.
Online Classes:	Students enrolled in all online classes may have a disbursement hold until the
	semester census date.
Federal Direct Loans:	Disbursed in one installment for the semester.
	New first-time borrowers will be disbursed 30 days after the start of their classes.
State-Funded Grants:	Disbursement dates for Cal Grants and SSCG depend on state funding availability.
Late-Start Classes:	Disbursements for classes starting mid-semester occur after classes begin.
Key Reminders	
Students must meet eligibility requirements for financial aid awards.
