# **Ribbon Cuttings Scheduled**

As some of the dust begins to settle for some of the major construction projects at the Compton Community College District, we are excited to announce upcoming openings and ribbon cuttings.

The ribbon cutting ceremony for the new Central Plant will be held on Tuesday, December 17 at 3:00 p.m. prior to the Board meeting. As part of the Phase 1 Infrastructure project funded by state capital outlay monies, the new central plant will supply cooling for buildings (excluding the row buildings) throughout the District grounds. This energy efficient approach will improve reliability and reduce the energy costs for the District.

The grand opening and ribbon cutting ceremony for the Learning Resource Center (LRC) building will take place on Tuesday, April 15, 2014, 2:00 p.m. preceding the monthly Board meeting. Watch for more details in future CEO Messages.

A ribbon cutting ceremony will also be held to mark the completion of the main road linking the campus to Artesia Boulevard and Greenleaf. As soon as a completion date is determined we will share the information.
