**RESOLUTION REGARDING PROVISIONAL APPOINTMENT OF A  
BOARD MEMBER**

**RESOLVED**, by the Board of Trustees of the Compton Community College District, County of Los Angeles, State of California that:

**WHEREAS**, on January 12, 2026, Trustee Barbara Calhoun submitted her resignation with a deferred effective date of February 1, 2026. On January 13, 2026, the President/Chief Executive Officer forwarded Trustee Calhoun's resignation to the Los Angeles County Superintendent of Schools; and

**WHEREAS**, Trustee Calhoun's resignation creates a vacancy in Trustee Area 2, representing the communities of Willowbrook, Enterprise, Compton, and West Rancho Dominguez; and

**WHEREAS**, Trustee Calhoun was most recently re-elected on or about November 5, 2024, to a four-year term serving Trustee Area 2, and the next regularly-scheduled election for Trustee Area 2 will occur in November, 2028; and

**WHEREAS**, California Education Code section 5091(a)(1) requires the Board of Trustees to either appoint a provisional board member or order an election to fill the vacancy created by the resignation of a board member; and

**WHEREAS**, a provisional appointment, unless successfully challenged by a petition calling for a special election pursuant to Education Code section 5091(c), confers all powers and duties of a governing board member upon the appointee immediately following his or her appointment.

**WHEREAS**, insofar as the next regularly scheduled election for district governing board members that is scheduled 130 or more days after the effective date of the vacancy (i.e. February 1, 2026) will occur on November 3, 2026, an appointee will hold office until the date of the next regularly scheduled election on November 3, 2026, unless a timely petition by registered voters for a special election, with sufficient signatures, is approved by the Los Angeles County Superintendent of Schools.

**WHEREAS**, the County of Los Angeles Registrar of Voters can provide an estimate of the cost of an election to fill the vacancy on a provisional basis, however, it is expected that the cost of such an election would be a significant unbudgeted expense for the District; and

**NOW THEREFORE BE IT RESOLVED AND ORDERED AS FOLLOWS:**

1. That the Board of Trustees hereby determines to proceed to fill the vacancy in Trustee Area 2 by making a provisional appointment pursuant to Education Code section 5090 et seq.;

2. That the Board of Trustees delegates to the President/Chief Executive Officer, all authority necessary and proper to the accomplishment of the purposes of this Resolution.
