#### BSD 1 RESOLUTION FOR PROVISION OF REPAIRS OF HVAC AND EMERGENCY POWER SYSTEMS IN THE MIS BUILDING

#### **RESOLUTION NO. 07/08-052908**

It is recommended that the Special Trustee approve entering into a contract with the firm of Southland Industries to provide the necessary construction and engineering services for work necessary for the repair and installation of an HVAC system to provide cooling to the server in the MIS building.

Authority to enter into the contract with Southland Industries is provided pursuant to Emergency Resolution No. 07/08-052008

The cost for these services, \$258,500, was negotiated considering the factors of project scope, level of complexity of the work required and the need to complete the work quickly.

The firm of Southland Industries was selected based upon its experience and expertise performing this type of project and its prior experience with the District. A copy of their proposal is attached for review. The firm of Atkinson, Andelson, Loya, Ruud & Romo is preparing the contract documents.

**Cost:** \$258,500; progress invoiced monthly.
