# MESSAGE FROM INTERIM CEO DR. KEITH CURRY

For those of you I have not yet seen to extend my best wishes for the New Year, let me take this opportunity to wish each of you a happy, healthy and prosperous New Year!

Winter Session at the Compton Center is in full-swing, the Governor has released his 2013-14 proposed budget, and we are gearing up for the start of the Spring Semester. Looking to the remainder of the 2012-13 fiscal year, at this time we are still determining the impact the passage of Proposition 30 will have on the Compton Community College District budget. Once we receive more information from the state, we intend to share that with the Planning and Budget Committee as well as all employees through the CEO Message.

We are pleased to report a hugely improved Financial Audit Report for fiscal year 2012 (year ending June 30, 2012). Below are some of the highlights of the report:

- For the first time since 2003, the Compton District has complied with the 50 Percent Law.
- The audit was completed and filed on time with the state meeting the December 31, 2012 deadline.
- The District ended fiscal year 2011-12 with a general fund reserve of \$4.4 million, slightly above the five percent recommended minimum reserve requirement.
- The District made significant improvements relative to the number of audit findings for fiscal year 2012 reducing the number of findings from 26 in fiscal year 2011, to 13 findings in fiscal year 2012. Of the 26 audit findings in 2011, fourteen were found to be fully implemented in 2012; eleven were noted as improved; only one was not implemented. Additionally, there were no material weaknesses noted for the fiscal year 2012 financial audit (fiscal year 2011 had ten material weaknesses).

A special thank you to Chief Business Officer Felipe Lopez and his staff for their work, as it has brought about significant improvements with our 2012 Financial Audit. However, there is still a lot of additional work that needs to be accomplished in the Administrative Services Division.

SUBJECT: Academic Affairs Reorganization

The attached proposal represents the proposed changes in the academic divisions for the Center. With Dr. Dever's retirement, we looked at ways to restructure that would benefit the Center in its move toward accreditation. Our initial goal was to free up funds to allow us to increase our administrative capacity in key areas however after a careful review it was determined that the academic program needed three deans. With that in mind, our focus was student success. In an effort to equalize the divisions and consolidate those programs deemed critical to student success, we brought all the programs directly related to student success – both academic and support services, under one division. As a result of this reorganization, the Board will be asked to approve two new job descriptions for the academic programs – Dean of Student Learning and Dean of Student Success.

Fiscal-Year 2012 Annual Financial Report

Below is a summary of results regarding the fiscal-year 2012 Annual Financial Audit Report:

### District Highlights

- District has complied with the 50 Percent Law. Since as far back as 2003, the District has not complied with the 50 Percent Law.
- The District audit is complete and will be filed on time to the State by the December 31, 2012 deadline.
- The District will end the FY2012 with a general fund reserve of \$4.4M which is above the 5% recommended minimum reserve requirement and noted no general fund audit adjustments.
- The District went from twenty-six (26) audit findings in FY2011 to thirteen (13) audit findings in FY2012.
- Of the twenty-six (26) prior-year audit findings, fourteen (14) were noted as fully implemented. Eleven (11) were noted as improved and are currently being addressed, and one (1) was noted as not implemented.
- Most importantly, of the twenty-six (26) prior-year audit findings, ten (10) were deemed material weaknesses. The District is proud to report no material weaknesses were noted during FY2012. All ten (10) material weaknesses were either fully implemented or improved to a status of significant deficiencies.
- Several construction and modernization projects are in progress and/or have been completed which include:
  - Utility Infrastructure Phase 1
  - o Central Plant/Stadium Lighting
  - Utility Infrastructure Phase 2
  - o Allied Health Renovation
  - o Emergency MIS Project

FY2012 Measure CC Bond Audit

Both the Financial and Performance under the provisions of Proposition 39 audits for the Measure CC General Obligation Bond were completed by our auditors, Vavrinek, Trine, Day & Co., LLP. Below is a summary of the results from the FY2012 Measure CC Bond Audit in accordance of Proposition 39:

The financial audit highlighted the following results:

- Total assets of \$24.7 million
- Available fund balance of \$24.3 million
- Total revenues of \$131 thousand
- Total expenditures of \$5.1 million
- Issuance of Series 2012C of \$15 million
- Restatement of beginning fund balance increase of \$1.1 million
- No deficiencies in internal controls over financial reporting were identified
- One instance of noncompliance were identified under Government Audit Standards

The performance audit highlighted the following results:

- 1. Reviewed District procedures for disbursement of funds related to the voter approved Measure CC bond funds
- 2. Reviewed detailed account of expenditures to determine if proceeds were spent on administrative salaries or any other expense of that would otherwise be the obligation of the General Fund
- 3. Tested and audited \$4.7 million of the \$5.1 million expenditures spent during FY2012.
- 4. Analyzed the balance of the Bond Funds available for future projects
- 5. Reviewed minutes of meetings of the Citizens' Oversight Committee.

### Conclusion

District has properly accounted for the expenditures held in the Bond Fund and that such expenditures were made for authorized Bond projects. Except for the District is required under the provisions of Proposition 39, the Citizens' Oversight Committee did not meet at least three times each year during FY2012.

General - In general, current projects at the District are moving forward. The Facilities, Business, and Administration offices have been working together to process contractor/consultant invoices timely. Blanket Purchase Orders for the Bond Projects opened in the 2012/13 fiscal year will remain open indefinitely based on contract amounts and construction schedules to assist with tracking expenses/invoices against each project.

The District has several projects that require DSA close-out. Those projects include the LRC, CDC, Stadium, Voc Tech, and Math/Science. The District issued a Request for Proposal (RFP) in late August to hire a DSA close-out specialist and Architect of Record (for the LRC). The top ranked proposer, NTD Architecture, was board approved in January 2013.

### I. LRC Project

The new LRC Architect of Record, NTD Architecture, will work to furnish specifications and drawings to go out for bid and select a contractor to finish the LRC so that it will open in the spring of 2014. Final acceptance of the LRC project by DSA will require the closeout of construction change documents (CCD) for the LRC Project.

Interior Programming & Completion - HMC has finalized the interior programming. They will work briefly with the new Architect of Record for the LRC to incorporate the changes into drawings and specifications.

HVAC Modifications - The Chevron settlement agreement is still being discussed between the attorneys.

- II. Music Building Renovation (Y-Area / Little Theater) The District finalized a settlement agreement with the previous Architect, Elements and paid them in early September. The District issued a Request for Qualifications (RFQ) for a new Architect for the Music Building Renovation in September 2012. The current total project budget is 1.2 million. Four firms responded. Presentations by the four firms were held on November 26, 2012. The Business Office has finalized the ranking and notified the Architects. Negotiations were finalized with WLC Architects in early January and they are scheduled to go to the board for approval in February 2013.
- III. Server Room and MIS Building Enhancements Dr. Curry authorized the transfer of a million dollars into the MIS Project budget. This amount should cover recommendations (HVAC, window closure, Voip) submitted that are necessary to ensure ongoing operation of the MIS data storage going forward. Phase 1 of the project was completed in November 2012. Remaining phases are dependent upon future budget allocations. The notice of completion is headed to the board for approval for February 2013.

- IV. Phase 1 Central Plant / Stadium Lighting The Central Plant under slab utilities are installed. The layout of foundations and reinforcing steel is in progress. Anticipate placing foundation concrete the week of Feb 11<sup>th</sup>. The Central Plant Equipment is scheduled to be delivered in March 2013. Stadium lighting fabrication is in progress.
- **Phase 1 Utility Infrastructure** Construction along the Row Buildings Corridor is complete. Construction at the East side of Voc Tech Building and the Quad continues. The scope of work includes the installation of 10" Fire and Sanitary Sewer lines, 2" gas line and Main Electrical Lines. We anticipate progressing south along the LRC corridor within the next two weeks. Construction of the West Road near the Childcare Development Center is in progress. Dry weather and the resolution of the SCE main electrical feed has improved condition for final grading and the installation of base material. asphalt paving is anticipated the week of Feb 4<sup>th</sup>.
- V. Phase II Utility Infrastructure Installation of the chilled water lines and 24" sewer system, and Communication lines in parking Lot F continues. Demolition of the Asphalt parking in lots D and E are in progress. Installation of branch utilities lines between the Row Buildings are near completion.
- VI. Allied Health The Allied Health bids were received as scheduled on January 22<sup>nd</sup>. Thirteen firms submitted bids. Bids are scheduled to be reviewed by the district prior to announcing the lowest successful bidder.

# Compton Community College District Special Trustee Appoints New Member to Citizens' Bond Oversight Committee

Irene Shandell has been appointed by Compton Community College District (CCCD) Special Trustee Thomas Henry to serve on the Citizens' Bond Oversight Committee as a community-at-large representative. Shandell will serve a two-year term.

As outlined in Education Code Section 15278, the role of the District's Citizens' Bond Oversight Committee is to "inform the public concerning the District's expenditure of revenues received from the sale of bonds authorized by the voters." Members are appointed for either a one- or two-year term, with a two-term maximum, and they do not receive any compensation or benefits for their service.

Shandell is retired from the Internal Revenue Service where she supervised revenue officers.
