

DR. KEITH CURRY

Thank you to everyone who participated in our Staff Appreciation Breakfast last week. Whether you helped cook, serve, clean; or joined us as one of our valued employee guests, everyone appeared to enjoy the food and good company.

Dear Dr. Curry:

As noted in our meeting with the Compton Community College District on December 7, 2011 and again by e-mail to the District and the State Chancellor's Office, the financial statement and compliance audits for the year ended June 30, 2011, for the District would be delayed until January 2012.

Due to changes in staffing as well as changes to the financial reports for the year ended June 30, 2011, information that is necessary to complete the audits was not available during our audit visit the week of November 28. We completed many of the necessary procedures, however, Federal and State compliance procedures were not completed. The audit of Instructional Service Agreements, and Contact Hours will be concluded next week, during the dates of January 10 – 12. Additionally, it has been noted that the federally funded child care grants were recorded in the financial records as State revenue and not included in the testing of Federal compliance; this will also be concluded next week. We are continuing to perform procedures over the balance sheet accounts, and revenue and expenditure accounts as additional journal entries were being noted, reviewed, and posted up to December 1.

All audit related verification procedures and compliance testing will be concluded no later than January 20, 2012, to provide sufficient time for you and staff to review the comments and results of the audit, and complete the required reporting to the Special Trustee and the State Chancellor's Office no later than January 31, 2012. If additional time is necessary to complete these procedures, we will promptly inform you of the delay and the required additional amount of time to complete the procedures.

In addition to the District financial statement and compliance audits, we will be conducting a close out audit of the Perkins Loan Program during the dates of January 10 – 12. We anticipate the report to be finalized no later than January 31, 2012.

We will also be completing the financial statement and program compliance audit of the Proposition 39 General Obligation Bonds during this period of time with the anticipated completion and reporting no later than January 31, 2012.

Per your request, below is a summary of budget transfers.

- I. a. Reserve for Contingency  
Total Transfer Amount - \$61,404
  - \$46,404 to cover salary and benefit cost of a classified employee; \$15,000 to Instructional Supplies for Academic Programs, Natural Sciences, and Life Sciences departments.
  
- II. a. General Fund - Unrestricted  
Total Transfer Amount - \$1,127,092.51
  - Academic Salaries - \$36,000 to allocate budget to the correct salary code and \$156,000 correction of coding error for Special Trustee salary; from Academic Salary to Contract Services.
  - Classified and Other Nonacademic Salaries & Employee Benefits - most of the transfers represent reallocation of dollars to the proper object codes where expenses were charged.
  - Supplies and Materials – majority of transfer amount remained within the Supplies and Materials major object group. Some funds were moved to the personnel and benefits object codes to cover Student and other Hourly workers.
  - Other Operating Expenses and Services & Capital Outlay – The majority of transfer reallocated funds originally coded to Capital Outlay into Contract Services to pay vendors from the proper code.
  
- b. General Fund – Restricted  
Total Transfer Amount - \$317,579
  - Most of the transfers represent establishment of restricted grants and State awards as well as a reallocation of dollars to the proper object codes.

- III. a. Child Development Fund (CDC)  
Total Transfer Amount - \$204,587
- Revenue budget transfer done to recognize the shift of federal dollars into the Child Care Development contract. The contract was previously 100% State funded.
- b. Bond Revenue Construction Fund  
Total Transfer Amount - \$8,308,255.70
- Transfers completed to distribute Bond Fund dollars in anticipation of payments for Contract Services, Site Improvements, Testing and Inspection, Architecture and Engineering, and New Equipment (Non - Instructional).
- c. Self-Insurance Property and Liability Fund  
Total Transfer Amount - \$35,000
- Increased overall budget in anticipation of expenses through 6/30/12.

AYC will be providing the following services to assist the District in its continuing disclosure responsibilities:

1. Preparation of the annual continuing disclosure report that will meet the continuing disclosure obligations of the District. This report will be submitted to the District for review and approval. Once approved, AYC will file this report to the Municipal Securities Rulemaking Board's compliance website, Electronic Municipal Market Access or EMMA.
2. Monitoring of listed events. This includes:
  - a. Changes in the District's credit ratings
  - b. Changes to the bond insurers' credit ratings or ownership
  - c. Changes to the general tax laws by the IRS or the State of California
  - d. Changes to the name or ownership of the bond trustees
3. If an event occurs that might need to be reported, AYC will notify the District to obtain approval to proceed with an event filing. Once approved, AYC will file the event notice on EMMA.

## Compton Community College District Publishes Redistricting Action Plan

The Compton Community College District (CCCD) recently published its redistricting action plan as part of a public process to review and modify the elected trustee area boundaries.

Every 10 years, local community colleges, city councils and other local agencies must adjust their elected trustee area boundaries in order to equalize the population. Currently, trustees in the CCCD must live in the trustee area they represent. Residents vote by "trustee area," whereas, they may only vote for candidates who reside in their specific trustee area.

In September 2011, the CCCD initiated discussions on the process required to modify trustee area boundaries. In November, the District made a public request for applications from those who are interested in serving on the District's Redistricting Committee.
