

Dear Special Trustee Henry:

At the May 21, 2013 Board of Trustees meetings the following questions were asked about the revised Partnership Agreement between the Compton Community College District and El Camino Community College District. Included below are the questions along with the Compton District responses.

1. Please provide clarification for item 12A of the Partnership Agreement. Was this language included in prior Partnership Agreements?

District Response: Prior to Compton District assigning an employee to provide services for the Center, El Camino College has the right to review the employee's qualifications and to determine if the assignment is an appropriate assignment. This language was included in the 2008 Partnership Agreement between the Compton District and El Camino Community College District in section 14A.

2. Who determines the fee structure for the Associated Student Body? Please provide clarification for section 6B and 10A of the Partnership Agreement?


District Response: All El Camino College students' fees are approved by the El Camino College Board of Trustees. Section 6B of the Partnership Agreement allows for the El Camino College Compton Center to have an Associated Student Body organization that is separate and independent of the Associated Student Organization at El Camino College. This section allows the El Camino College Compton Center to have its own student council (i.e. President, Vice President, Treasurer, and other positions). In addition, section 6B allows for the El Camino College Compton Center Associated Student Body to assess and benefit from the fees collected from El Camino College Compton Center students. The funds collected are used to support the activities of the El Camino College Compton Center Associated Student Body.

Section 10A of the Partnership Agreement states that Compton District shall collect fees from El Camino College Compton Center students. Upon the recommendation of the Compton District, student fees are set by the El Camino College Board of Trustees. The fee amounts are set

by the El Camino College Board of Trustees because the Compton Center students are students of El Camino College.

If you have any additional questions or concerns, regarding the partnership agreement between Compton Community College District and El Camino Community College District, please let me know.

This memo provides a status update on the ASB Student Activity Fee (Measure A) that appeared on the ballot as part of the spring 2013 student elections. Measure A afforded Compton Center students an opportunity to vote on a voluntary \$10.00 per semester student services fee to fund increased student services, student programs and student activities on campus. Compton Center students were presented with an option of electing to pay or not to pay the Student Activity Fee via the placement of the \$10.00 fee on the student fee sheet at the time of registration.

A total of 290 students out of 7,543 (total headcount) voted in the spring 2013 elections. 212 students voted yes on Measure A, 73 students voted no and 5 students abstained. The results of the spring 2013 election saw the passage of Measure A by approximately 74% of the students who participated in the voting. 74% of the students who participated in the voting represent 3.8 % of the total student population for spring 2013.

Previously, the Student Activities Fee appeared on the spring 2009 election ballot. The measure passed in 2009 by a margin of 71%. Only 118 students voted in the 2009 election.

Implementation of the Student Activities Fee is now being reviewed by Senior Management from El Camino College and the Compton Community College District.

This memo provides a status update on the Upward Bound Math/Science (UBMS) summer program. The UBMS program kicked off its annual six-week summer program on Monday, July 1st. The summer program runs through mid-August. We are currently serving 40 high school students from Compton Unified School District. Eighteen students are from Compton High School and 22 students are from Dominguez High School. This cohort of students is the largest group in the history of the summer program.

Students spend the first five weeks (July 1st – August 1st) taking academic enrichment classes at the Compton Center. UBMS students take classes in English, Biology, Chemistry, Geometry, Algebra II, Pre-Calculus, and Calculus. Tutors provide an hour of homework support and tutoring to ensure academic success. Students receive lunch courtesy of the United States Department of Agriculture (USDA) and the California Department of Education (CDE). UBMS students take field trips and have guest speakers to encourage educationally disadvantaged students to pursue majors and careers in science. During the last week of the program (August 4th – August 9th) students experience university life by living in the residence halls at California State University, Fullerton.

Under the guidance of Elizabeth Martinez, Director of Enrollment Services, the UBMS summer program is staffed by Nelly Alvarado, UBMS Program Manager, 4 Teacher Associates, 2 Program Specialists, and 5 Tutors. With the exception of the fulltime program manager, all of the staff in the summer program are hired to work for 6 weeks during the summer.

General - In general, current projects at the District are moving forward. The Facilities, Business, and Administration offices have been working together to process contractor/consultant invoices timely. Blanket Purchase Orders for the Bond Projects opened in the 2012/13 fiscal year will remain open indefinitely based on contract amounts and construction schedules to assist with tracking expenses/invoices against each project.

LRC Project

The new LRC Architect of Record, NTD Architecture, has been working to furnish specifications and drawings to go out for bid to select a contractor to finish the LRC so that it can open in the spring of 2014. Due to the unique nature of the work necessary to determine the exact construction scope necessary to complete, closeout/certify and ultimately open the Library Learning Resource Center based on the schedule per our NTD/PCM3 contract, it was recommended and determined to use the process allowed by California Code section 4526 (Lease Lease Back) to include the completion contractor as part of the team that develops that scope of work. NTD/PCM3 recommended moving forward with P.H. Hagopian Contractor as the successful Lease Lease Back proposer. They were board approved in May 2013.

Final acceptance of the LRC project by DSA will require the closeout of construction change documents (CCD) for the LRC Project. Initially, there were 160 outstanding change orders (CCD). Upon further review by the new Architect, 130 change orders had already been DSA approved, leaving only 30 change orders still in need of DSA approval. The new Architect will also work to incorporate any interior programming modifications from the architect, HMC, that will not affect the DSA status or force a new DSA number.

HVAC Modifications - The Chevron settlement agreement is still being discussed between the attorneys. NTD/PCM3 has provided the District with a peer review of the current HVAC system. At least one air handler unit is recommended for replacement. The unit is undersized.

II. Music Building Renovation (Y-Area / Little Theater) – The current total project budget is 1.2 million. WLC Architect, the new architect of record for this project has been meeting twice-monthly with the District to prepare new documents for DSA submittal.

III. Server Room and MIS Building Enhancements –Phase 1 of the project was substantially completed in November 2012. Remaining phases are dependent upon future budget allocations. The District approved the purchase of additional server equipment in May 2013; and the additional security equipment in June 2013. Installation is scheduled for the July.

IV. Phase 1 - Central Plant / Stadium Lighting – Installation of Roof Trusses for Central Plant is complete. Robertson Decking has been installed and prepared for roofing materials. Parapet framing is continuing. Framing for Solar Panels is 50 % complete. Interior utility rough-ins for plumbing and electrical is continuing. Drywall was installed on one side of the building in preparation for DSA Inspection. Asphalt paving of the Central Plant is complete. The District has taken occupancy of the Central Plant maintenance yard, although Pinner still uses the area for ongoing construction. The Stadium Lighting design was also approved by DSA on May 24th; fabrication of the Stadium Lighting is underway and should be complete by the end of July.

Phase 1 – Utility Infrastructure – Construction is progressing in Segment 7, which includes the Main road from the Math/Science Building intersection to the eastside of the Administration Building. The access along the Main road will be blocked through October 2013. The scope of work includes the installation of 10" Fire line, Sanitary Sewer line, gas line, communication and main electrical lines and the complete redesign of the sidewalk and court yard. Installation of chilled water lines, storm drain, gas, water and fire main is continuing in Segments 3 and 6 near the Math/Science Road, with electrical and communications to follow. This area will remain closed through mid-September. All of the asphalt within the quad was replaced with concrete walkways. Approval of the resurfacing of Parking lots G and H is scheduled for July 2013 Board Agenda. Parking Lot G & H is scheduled to re-open in July. The District submitted a request to the State to utilize bid savings to fill-in the retention basin at the south end of Campus with an underground piping system. The design phase for the retention basin underground system is to be completed within the next three weeks.

V. Phase II – Utility Infrastructure – Installation of the asphalt at Lot F is approximately 95% complete; a portion of Lot F reopened 4/8; Installation of asphalt in parking lots D and E are complete; portion of Lot E reopened on Monday May 6th and the balance of lot E and lot D shall open after the completion of the main road due to restricted access. Construction along the main road continues to progress with the installation of Sanitary Sewer, Storm Drains, Chilled Water and electrical. Installation of the Fire Hydrant and Light Standard near Childcare is complete. Construction along the East Corridor of the Row buildings is in progress, the scope of work includes the installation of Chilled water, Gas, Sewer and Domestic Water lines. Work in the corridor is scheduled to continue through Sept 2013.

VI. Allied Health Building – The Allied Health Building bids were rejected. District is awaiting approval from State to re-bid.

El Camino College Compton Center's First Year Experience Program Sets Up First-Time College Students for Success

Since 2009, the First Year Experience (FYE) program at El Camino College Compton Center has helped students in their first year of college by providing a supportive educational environment that encourages student success through shared learning communities and services such as counseling, mentoring and orientation. The first year of the program, 67 students participated; by the second year, the enrollment more than doubled with over 140 students. Now completing its fourth academic year, the FYE program has served approximately 467 students collectively.

“FYE helps students see their full potential in their major,” said Edna Salas, an ECC Compton Center FYE student. “Transferring to a four-year college is much easier with all of the resources provided by the program.”

The simple definition of a learning community is a community where people learn from each other. In an academic setting like the FYE program at ECC Compton Center, a learning community is a structure in which classes are linked so that groups of students enroll in courses together. Sharing common schedules, students also make friends, form study groups, and discuss and socialize together outside of class. These student groups become a small community within the larger ECC Compton Center.

In a time where educational institutions are challenged to facilitate more learning with fewer resources, the goal of the FYE program is to provide clear pathways for student success and increased retention rates, as well as to facilitate transfer success by linking courses. Research shows that students who take part in a learning community earn higher grades, make friends faster, and graduate at higher or faster rates than students who don't participate.

Castro also served as the 2013 student speaker during the June 6 commencement ceremony. Castro and Celis received their awards at the annual Academic Awards Tea held in late May. Presidential Scholars represent students who have shown academic strength, singular focus and the desire to reach their highest potential, while overcoming obstacles in the pursuit of their dreams. Here are their personal stories of success.

Mariela Castro

Mariela Castro is graduating with a cumulative 3.84 GPA and has been accepted to California State University, Long Beach this fall to continue her studies in business administration. Castro, a single mother of two children, immigrated to the United States in 2005. She first enrolled at El Camino College Compton Center in 2010 with the goal of improving her English language skills. She worked full-time during the day and took advantage of the evening ESL courses offered at ECC Compton Center.

She has taken full advantage of the many programs and student services offered here, including financial aid, which enabled her to advance her education by pursuing an associate degree. Castro is proud she has maintained a high GPA throughout her tenure at ECC Compton Center, and credits the faculty and staff for providing guidance and the academic skills necessary to achieve her educational goals.

Through her experience at ECC Compton Center, Castro is convinced there are no limits when it comes to learning. She describes ECC Compton Center as being one of the greatest influences for change in her life. She believes the experience has helped her to be a better mother, serving as an exemplary model for her children as they set goals for themselves in the future.

Albino Celis, Jr.

Bellflower resident Albino Celis, Jr. decided to advance his learning at El Camino College Compton Center to overcome some of the socioeconomic barriers he faced growing up, and to provide a better life for his family. A young father with limited financial resources, Celis has carried up to 19 units per semester while also providing for his daughter. He has also managed to avoid the pitfalls that claimed many of his peers. Of the fifteen boys in his fourth-grade class, he is one of only three pursuing a bachelor's degree. He graduated from Paramount High School in 2009, and is thankful his sister, cousin and friends constantly reminded him about the importance of higher education and attending college. His plans now include transferring to a four-year college or university to major in business administration. After earning his bachelor's degree, he hopes to attend law school.

As part of the ECC Compton Center's curriculum, Celis says he was introduced to complex works of literature, and attended a wide range of classes, including accounting, economics and law. He believes the exposure to new and advanced problem solving is what inspired him to seek out new possibilities and a future in the business world.

Celis praises ECC Compton Center, which he says allows its students "to discover that higher education is a self-fulfilling journey of enlightenment." He believes the school has greatly enhanced his critical-thinking skills while providing him with an outstanding education.
