Mr. Lopez, Chief Business Officer, distributed copies of and reviewed the 2013-2014 CCCD Budget, highlighting the District budget, impact of the state budget, and what challenges lie ahead for us.

VIII. Discussion/Information Items:

1. Review of the Special Trustee's Advisory Committee 2013 Goals

Dr. Curry stated that September 20, 2013 is the deadline for completion of Goal #1 (Participation in community activities).

Goal #2 (Participation in Advisory Committee Meetings): there has been an improvement in committee attendance and members not able to attend have called in.

Goal #3 (Fiscal Responsibility): items a, b, c and d have been completed, and a revised copy of the Five-Year Budget Assumptions will be presented (item c) at the December 16, 2013 Advisory Committee meeting. Item e (Measure CC Bond Expenditures) has been presented to the community and an update will be provided.

Goal #4 (Support the Partnership with El Camino College District): Items a and b have been completed; Vice President Barbara Perez will give an update and timeline for accreditation at the December 16, 2013 Advisory Committee meeting.

2. Accreditation Basics Workshop & Ethics Training

Dr. Curry reported that six of the seven committee members have completed the Brown Act Training. Four of the seven members have completed the Accreditation Basics Workshop. Two individuals have completed the Ethics Training and the deadline for completion is September 20, 2013.

3. Special Trustee's Advisory Committee Community Meetings Talking Points The Community talking points have been developed and Dr. Curry has appointed Dr. Johnson, Ms. Hollis, and Ms. Henderson to the subcommittee. They will meet before the October 21, 2013 meeting for recommendations to present to the committee.

4. Compton Community College District Board of Trustees' November 2013 Elections.

Dr. Curry announced that an information session will be held for potential board candidates on August 27, 2013 at 5:00 p.m.

Dr. Johnson proposed holding a forum at the Chamber of Commerce office for board candidates to state their positions.
