- VII. Discussion/Action Items

- A. Compton Community College District Bond Expenditure Report Dr. Keith Curry reviewed the Compton Community College District Budgets and Actual Expenditures for the 2002 Measure CC as of January 31, 2020 including:
  - Total Budget for New Construction, Renovations, Campus-Wide Projects = 14,147,000.
  - Total Expenditures for New Construction, Renovations, Campus-wide projects = \$3,047,299.
  - Remaining Balance for New Construction, Renovations, Campus-wide projects = \$9,299,701.
- B. 2018-2019 Measure C and Measure CC General Obligation Bond Financial Audit and Performance Audit Report.

Dr. Keith Curry reviewed the Proposition 39 General Obligation Bonds Measure CC and Measure C Financial and Performance Audits dated June 30, 2019. This report included:

- Independent Auditor's Report;
- Balance Sheet;
- Statement of Revenues, Expenditures, and Changes in Fund Balances;
- Notes to the Financial Statements;
- Independent Auditor's Report on Internal Control Over Financial Reporting and on Compliance and Other Matters Based on an Audit of Financial Statements Performed in Accordance with Government Auditing Standards;
- Schedule of Findings and Responses.

The Performance Audit of General Obligation Bond Fund Measure CC and Measure C included:

- Independent Auditor's Report;
- Background Information;
- Objectives;
- Scope of the Audit;
- Procedures Performed;
- Conclusion;
- Schedule of Findings and Responses.

Dr. Curry reported this was a clean audit and there were no audit findings or recommendations. This report talks about activities of the Bond Program over the past year and also includes

other information on the bond audit. This report is published on a yearly basis and is also posted on the website.

C. 2018-2019 Citizens' Bond Oversight Committee Annual Report for 2018-2019. Keith Curry reported that staff is currently working on the Oversight Committee Annual Report which contains a lot of Bond information and will be presented at the next Oversight meeting for review, discussion, and approval. Once this report is completed the Oversight Committee Chair will be asked to present this Oversight Committee Annual

Report to the Board of Trustees. Dr. Curry stated that this report is mostly financial, but also provides an update on the facilities projects and stats.

#### VII. Comments by Oversight Committee members:

Irene Shandell-Taylor reported that the community has a lot of nice, historic items (pictures, trophies, etc.) in the gym that need to be cleaned and preserved.

Marjorie Shipp reported that she will not be able to attend the April 9, 2020 meeting.

Adele Johnson stated that the athletic field looks very nice and doesn't seem to need any more renovations. Linda Owens responded that the work in this area is totally different and these will be additions. There will be a tennis court, volleyball, and soccer field added to the east of the football field.

Elizabeth Atkinson commented that we know things come up but is pleased they were able to continue the work is spite of challenges.
