IX. Presentation – Compton Community College Update

Dr. Curry commented that we are moving forward with facilities upgrades, and one of his goals is to continue to build out CCCD and CEC facilities. We will not be able to attract or keep students if we do not upgrade our facilities, including heating/air conditioning, wi-fi connections, etc. Our goal is to fix these things. Everyone can offer classes, but what else is being offered; what types of programs are being offered; how are the facilities? We are looking at how much of our bond dollars can be utilized for some of these projects. We still have \$29M in unsold bonds. I am exploring the possibility of selling more bonds.

Dr. Curry reported that the District is exploring the possibility of selling additional bonds; item will be on the October 2013 board meeting agenda for approval.
