- Danielle Daniels commented that she enjoyed the tour and noted that some other member expressed concerns about the limited access to the Campus Police Department, but now understand the security issues. Ms. Daniels commented that she had been a student here and noticed all the positive changes.
- Mr. Haigler summarized their tour, which included: Campus Police, Instructional Building #1, Math Science building renovations, Vocational Technology Building; and Child Development Center.

Resignation – Steve Haigler announced that at the next meeting there will be a new Vice President of Administrative Services as he has accepted a position at another college.

- IX. Comments by Oversight Committee members:
 - Rodney Lister asked if the committee could have a copy of the most recent weekly construction project meeting report at the February 2020 meeting, in order to get a better idea of what stage things are at, large ticket items versus small ticket items?

Steve Haigler responded that we go through a public bid process to award contracts. Once the bid is accepted I draft up a contract which I sign on behalf of the district and the vendor signs. Then I set up an excel schedule so every time I receive one of these progress notices it has to go through a process where it gets several signatures including the architect, facilities director, construction manager and other appropriate signatures. Then it comes to me for payment. I have a tracking system where I actually track the payments against that contract, and I can easily provide that. All construction payments are reviewed by the L.A. County Office. Mr. Lister said that would be great.
