Mr. Lopez encouraged all committee members to attend the Grand Opening of the new stadium on Tuesday, September 9, 2015 @ 1:00 p.m.

Most of the community colleges in California are having low enrollment rates; those in Northern California are suffering a little more than Southern California. San Bernardino and Riverside counties are doing well, but the majority of Los Angeles has had a slight dip in enrollment.

Mr. Lopez responded that we are making a lot of outreach efforts, enrollment management, and outreach to local high schools.

Dr. Brown suggested sending busses to bring students to the college to see what is available to them here.

Mr. Lopez said that twice a year we have two major events with Compton High School during which students are brought here; we also starting to reach out to surrounding school districts, and offering them to hold some of their home football games on this campus. We hope with our new and improved facilities, they will want to come here.

Mr. Lopez gave an update on the status of the newly installed WiFi. Mr. Edmonds suggested putting up banners stating that WiFi is available throughout this campus.
