- A. Compton Community College District Bond Expenditure Report for Measure C and Measure CC – Stephen Kibui, Vice President, Administrative Services, reviewed the Compton Community College District 2002 Measure CC Budget and Actual Expenditure Report, including:
 - Total Budget for New Construction, Renovations, Campus-wide Projects = \$14,147,000.
 - Total Expenditures for New Construction, Renovations, Campus-wide projects = \$5,458,540.
 - Remaining Balance for New Construction, Renovations, Campus-wide projects = \$8,688,460.

Compton Community College District 2002 Measure C Budget and Actual Expenditures Report, including:

- Total Budget for New Construction, Renovations, Campus-wide Projects = 100,000,000.
- Total Expenditures for New Construction, Renovations, Campus-wide projects = \$2,363,047.
- Remaining Balance for New Construction, Renovations, Campus-wide projects = \$97,636,953.
- B. 2018-2019 Citizens' Bond Oversight Committee Annual Report Stephen Kibui provided the Citizens' Bond Oversight Committee Annual Report for 2018-2019 to the committee for their review.

As outlined in Education Code Section 15278, the role of the Compton Community College District (CCCD) Citizens' Bond Oversight Committee is to "inform the public concerning the District's expenditure of revenues received from the sale of bonds authorized by the voters." Members are appointed for two years, with a twoterm maximum. Members do not receive any compensation or benefits for their service. The committee meets a minimum of four times per year. During the 2018-19 fiscal year, the Citizens' Bond Oversight Committee met a total of six times.

During this year of existence, the committee has met on a regular basis: reviewing expenditures, touring campus renovations, asking questions, and expressing concerns and recommendations. This Annual Report of the Compton Community College District Citizens' Bond Oversight Committee documents the results of these activities and serves to fulfill the basic tenets of the charter.

This report is the independent financial and performance audits for the fiscal year ending June 30, 2019, performed by the firm of Clifton, Larson Allen, LLP. The committee examined and reviewed this audit.

- C. Facilities Update Linda Owens, Chief Facilities Officer, gave an update on Compton College Projects, which included: Bond Projects:
 - Public Safety Building (Campus Police) Complete
 - Student Services Old library demolished; in process of over-excavating to prepare foundation. Should be completed in December 2021.
 - Administration Building renovation will start after Student Services Building has been completed.
 - Vocational Technology Building In programming and design phase; meeting with architects in two weeks.
 - MIS/Math/Science Buildings Renovations On hold until Vocational Technology Building is complete.
 - Child Development Center (Abel B. Sykes-Building T) Renovation This is a \$3M project. Plans have recently been reviewed and we may receive additional funds from the State. FPP (Final Project Proposal) to be submitted.

- PE Complex Replacement current budget \$46M; waiting for approval from State Department of Finance.
