

## Recommendations to the President/CEO

### *UndocuAlly Task Force*

#### **Background:**

The UndocuAlly committee serves to identify, assess, and implement strategies to assist our undocumented/AB540 students with their enrollment, persistence, and completion of their academic goals. Many of our students either identify as undocumented or have family or friends who are dealing with immigration or legal status issues.

Here at Compton College, we have a number of students who do not identify as U.S. citizens. Below is the current count of Compton College students coded as (F) foreign Summer/Fall 2019. Students coded as (F) foreign indicated "No U.S. Citizenship in their CCCApply Application".

- Summer 2019: 120 students
- Fall 2019: 307 students
- Winter 2020: 352 students
- Spring 2020: 367 students

*\*\*\* Note, Winter and Spring enrollment is currently just starting, so those numbers will increase significantly (our target population is increasing per semester).*

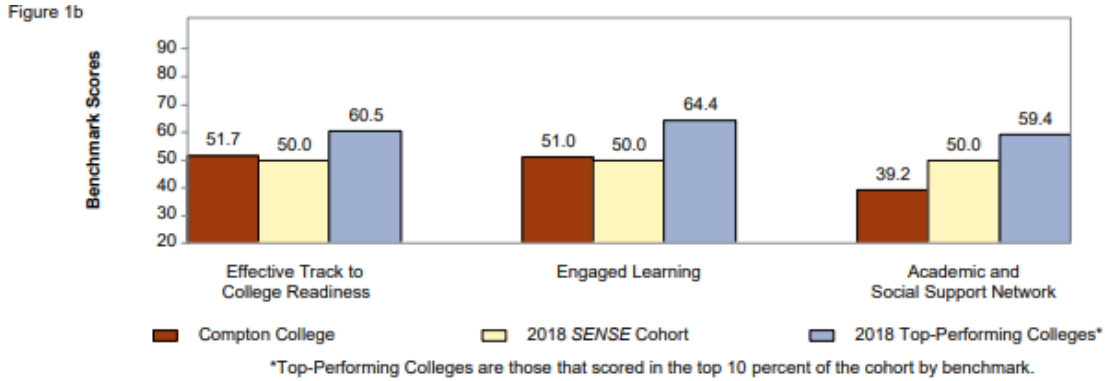

To increase engagement of undocumented students, the UndocuAlly Task Force will set out to do the following:

- Create a campus wide environment of inclusion by training faculty and classified staff in working and supporting undocumented students.
- Create a campus wide environment of inclusion by displaying signs of visual representation of support.
- Provide continuing professional development to faculty, classified staff, and administration.
- Host workshops in collaboration with St. John’s Well Child and Family Center and other partners to provide emotional and social support.
